Notes of survey and attached map of
proposed County of Greenwood, South Carolina.
Said County to contain six hundred
and forty three square miles (643).

How
formed to be formed from Abbeville county, three
hundred and sixty seven (367) square
miles; Edgefield county, two hundred
and twenty two (222) square miles; Laurens
County, fifty four (54) square miles,
aggregating as above, six hundred and forty
three (643) square miles.

Boundaries Beginning at Smith's ferry on
Saluda river, at a point on the Abbeville
and Laurens counties line: thence up the
middle line of Saluda river to the town-
ship line between Donalds and Cokesbury
Township: thence S. $47^{\circ}20'W$. 5.27 miles along
this Township line to the point when it is
crossed by the Columbia & Greenville Rail-
road: thence S. $7^{\circ}E$. 5.38 miles to the middle
of the bridge over Long Cane creek, near
Douglas's mill: thence down and along the
middle line of Long Cane creek to Morton's
bridge, where the road from Greenwood
to Abbeville crosses Long Cane creek;
thence S. $46\frac{3}{4}^{\circ}E$. 3.07 miles to the crossing of
Curl Tail creek by the 5 notch road: thence
down the middle line of Curl Tail creek
to its mouth: thence down the middle line
of Long Cane creek to the Jordan old mill
place. At this place the corner is on the South

end of an island in the creek and is seventy five (75')
feet from a closed sweet gum tree, growing near the
East Bank of the creek, said tree being a live tree on
the course from this corner: Thence S. 13° E. 6.38
miles, to a post near George Syberts house, being
a mile stone on Augusta and Knoxville Rail
road, said post being between said Rail road
and George Syberts house: Thence S. 33° E. 3.83
miles to the Edgefield County line at point
crossed by Rocky creek: Thence down
the middle line of Rocky creek to its mouth;
Thence up the middle line of Stevens creek to
Cupper town creek: Thence up the middle
line of Cupper town creek to the Shinkens bridge:
Thence along ^{the middle line of} road, crossing the Shinkens bridge,
to its crossing of the Scotts ferry road at
Liberty hill: Thence along the middle line of the
Scotts ferry road to its intersection with the
5 notch road. The Scotts ferry road having
two intersections here with the 5 notch road,
the corner is determined by projecting the
middle line of the Scotts ferry road through
two points in the middle of that road, respectively
200 feet and 500 feet from the 5 notch road,
on that line, the intersection of this line with
the middle line of the 5 notch road is the corner:
Thence N. 64° E. 15 miles to Good hope
Church, the corner being thirty feet (opposite)
from the front door of the Church on N.W.
side of Church: Thence N. 41 1/4° E. 10.2 miles
to the Saluda old town road, where it is
crossed by the Charleston road. The corner

is determined here by the crossing point of the middle lines of the two roads: thence along the middle line of the Saluda old town road (or old town road as it is sometimes called) to the ferry on Saluda river, to the middle of the river: thence up the middle line of Saluda river to Island ford, at the corner of Abbeville, Edgefield, Newberry and Laurens counties: thence along the County line road between Newberry and Laurens counties to the Lou Harris house, now occupied by J. Hill, near where the road from Spring grove intersects the County line road, the corner here is opposite and 30 feet from a Post Oak, marked, on the East side of the county line road, S.E. from the Lou Harris house: thence N. 70° W. 10.81 miles to the middle point of bridge over Reedy river, near Wright Sims residence, where this line enters the Corporate limits of the town of Cross hill, the Corporate limits become the line to the point where the straight line passes out of these limits, so as not to include any portion of the town of Crosshill in the proposed County. Thence S. 88 $\frac{3}{4}$ ° W. 4.54 miles to the point of beginning at Smiths ferry on the Saluda river.
