- III. Goals & Committee Planning

V. Aerial Imagery 2026

Christy Jacobs updated the GIC members that RFA has gone through the Request for Proposal (RFP) process with State Procurement and expects to choose a vendor by November.

VI. Statewide Data Status

Christy Jacobs informed GIC members that the statewide centerlines and roads are complete. The statewide parcels should be completed soon and will be available on the FTP site by October 2025.

VII. SCEMD Presentations

- A. Andrew Phillips presented on how SCEMD prevents disasters using information and data from people in the state. i.e. summary risk assessment, storm surge modeling, and flood inundation.
- B. Melissa Potter exhibited the DIG dashboards, use cases, and how the SCEMD creates applications for different needs depending on weather data.
- C. Eryne Sheffield discussed the statewide common operating picture and the ability to perform situational awareness and analysis.

Christy Jacobs introduced the idea of GIS augmentees moving forward to provide geospatial support during emergencies.
