South Carolina Revenue and Fiscal Affairs Office

General Fund Revenues Overview July to August, FY16

- Collections exceed monthly estimates by \$32.4 million or 3.3%
- General Fund Revenues for July through August grew 7.1%
- Revenue growth needed to meet estimate is 2.0%
- Bulk of excess attributable mostly to better than expected growth
- Continuation of faster growth noted in May

Actual Forecast July to August FY16

Sales Tax

- Excess revenue of \$2.4 million or 1.0%
- Actual growth of 5.1% compared to estimate of 4.0%

Individual

- Actual growth of 5.7% compared to 2.8% growth needed to meet forecast
- Revenue exceeds estimate by \$11.4 million or 1.6%
- Withholdings grew 5.8%

Corporate

Revenue exceeds estimate by \$18.4 million or 2628.6%

Other Revenue

Revenue exceeds estimate by \$0.4 million or 1.0%
