- 1. Chairman Walldorf called the meeting to order.
- 2. The minutes of September 30, 2014 were approved.
- 3. Frank Rainwater presented agency updates. (See attached)
- 4. Frank Rainwater presented budget information for FY 2015-16. (See attached)
 - ~Chairman Walldorf commended Frank and staff on decreasing the budget and taking on additional responsibilities.
 - ~Frank Rainwater and Emerson Gower agreed that the staff had worked hard to reach this goal.
- 5. Frank Rainwater presented information on the agency head performance planning document. (See attached)
 - ~Emerson Gower asked if the succession planning section was included and Frank Rainwater responded that it was. There were no other comments.
 - ~Chairman Walldorf asked for a motion to vote on the planning document; Emerson Gower made the motion; Howell Clyborne seconded and all voted aye to approve the planning document.
- 6. David Morrison provided information on the Wireless E911 program. (See attached)
 - An historical overview was provided.
 - David mentioned that the costs, in a large part are maintenance and people who answer the calls.
 - The E911 collections amount increased due to the fact that DOR deposited 18 months of collections in FY 2013.
 - The reimbursement percentage was raised from 40% to 70% which will be maintained going forward.
 - The prepaid wireless surcharge was introduced in FY 2011. Currently prepaid charges compose 21% of all surcharges.
 - For FY 2014 the number of cost recovery requests is estimated at over 200.
 - Interstates that pass through counties affect the number of calls. Refunds are based on these calls.
 - CMRS Advisory Committee requests that the reimbursement percentage for allowable costs be increased from 70% to 80% to match the percentage wireless calls constitute of total volume.
 - RFA is working on an RFP for a consultant to develop a strategic plan. RFA receives 2% of E911 funds for administration and will use these funds to cover the consultant fee.
 - ~Frank Rainwater thanked the CMRS committee and Jim Lake for their suggestion for a model. The model will make it easier to estimate costs.

- The CMRS Advisory Committee recommends that the annual wireless fee be set at the maximum allowable rate of \$.63.
- In September 2014 there was \$30.5 million in the wireless fee fund.
 - ~Chairman Walldorf is not in favor of raising the fee if there is a \$30 million balance. Would like to keep the rate at \$.62 but raise the reimbursement percentage to 80%. He suggested reviewing the Charleston model to manage the fund differently in order to lower the balance.
 - ~Jim Lake and Ted Creech agreed that looking at other models for cost efficiencies is a good idea.
 - ~Howell Clyborne asked what the dollar amount per year would be if the fee was increased
 - ~Frank Rainwater responded the increase would provide an additional \$500,000 annually. He recommended waiting to see what information the consultant provided.
 - ~Emerson Gower agreed and asked how many bids would be submitted-would there be at least three?
 - ~Frank Rainwater stated that he did not expect many, but would try for three.
 - ~Jim Lake mentioned he only knows of four companies in the country that may provide bids.
 - ~Chairman Walldorf asked if there were any more comments. If not, he recommended the Board vote on the reimbursement rate of 80% and wireless fee of \$.62.
 - ~Emerson Gower motioned for a vote, Howell Clyborne seconded and all voted aye.
