

General Fund Revenue

August Fiscal Year 2018-19



Revenue Digest

August 2018

General Fund revenue increased 8.1 percent during the month of August 2018 from August 2017. The monthly revenue gain was the result of strong Individual Income tax withholdings and the receipt of a Corporation Income tax audit received in August. Revenues through August 2018 have grown 9.2 percent year-to-date.

- Sales and Use tax revenue increased 4.4 percent for the month of August resulting in year-to-date growth of 4.4 percent. Retail sales tax collections have not experienced much momentum since the past holiday season, and have not kept pace with recent national retail sales trends. The cumulative Sales and Use tax revenue growth through August 2018 is running slightly ahead of the 3.7 percent revenue forecast for FY2018-19.
- The Individual Income tax revenue increased 9.0 percent during the month of August mainly from strong growth in Individual Income tax withholdings. Employer withholding tax activity was up \$30.5 million when comparing August 2018 to August 2017. Continued job growth and a state unemployment rate near a 20-year low has contributed to positive withholding growth. Total Individual Income tax revenue growth is 8.0 percent year-to-date through August 2018 and is well above the 0.4 percent revenue forecast for FY2018-19.
- Corporate Income tax revenue increased 185.8 percent in August 2018 primarily from the settlement of a single audit payment for \$11.4 million received. The Corporation Income tax has increased 133.4 percent through the first two months of FY2018-19.
- Other Revenues increased 2.0 percent in August 2018 from one year ago and have increased 7.1 percent year-to-date from a variety of sources and timing of receipts. The implementation of a new computer system at the Department of Revenue delayed the recordation of each of the "sin" tax revenues (alcohol, beer, wine, and tobacco) in August





2017 causing a distorted increase in those revenue categories in August 2018. Other Revenues have also benefitted from strong Interest Earnings on state General Fund investments.

Summary

Through the first two months of FY2018-19, General Fund revenues have increased 9.2 percent and are trending above the growth rate of 1.5 percent needed to meet the estimate for FY2018-19. The current Board of Economic Advisors' (BEA) revenue forecast is based upon an employment growth rate of 1.8 percent and a personal income growth rate of 4.25 percent in FY2018-19.

The BEA will meet with its Regional Advisory Committee in October 2018 to receive input about the health of the state economy and revenues from a group of business leaders and academics. The BEA will adopt and release a revised General Fund revenue forecast for FY2018-19 and a preliminary General Fund revenue forecast for FY2019-20 in November 2018.
