- 1. Chairman Grimball welcomed everyone to the meeting at 2:30pm.
- 2. Chairman Grimball presented the meeting minutes of the meeting for August 29, 2018 which had previously been shared with the Members and asked if any Member had additions or corrections. There were no comments from the Members and Chairman Grimball declared the minutes approved as presented. (See attached)
- 3. Frank Rainwater presented an overview of August 2018. **His major comments** were: (*See Attached*)
 - ~Revenue Surplus in FY 2017-18 means revenue growth of only 1.5 percent is needed to meet the current fiscal year's estimate.
 - ~Economic and revenue conditions continue to meet or exceed forecast assumptions.
 - ~Still analyzing the FY 2017-18 surplus for recurring and non-recurring trends.
 - ~Reviewing key assumptions and factors for the October Regional Advisors.
 - Chairman Grimball asked if the change in personal income numbers was due to the capital gains tax or the new tax act withholdings. Mr. Martin stated that the reason was mainly withholdings due to higher wages.

 - * Chairman Grimball asked if tariffs are affecting South Carolina and also if anything on the above list of concerns will affect the projected oil barrel price of \$72. Mr. Martin replied that if oil prices increase to \$80 per barrel, growth would slow. The tariffs

on agriculture and transportation equipment (car parts) would also slow growth.

5. Other Business

~Mr. Martin shared information concerning the Annual Regional Advisory Meeting. Chairman Grimball shared that he hoped Scott Baier from Clemson University, would be able to come and speak as that part of the state is growing so rapidly. He also would like the meeting to be very interactive.

Mr. Gower motioned to adjourn the meeting and Mr. Clyborne seconded the motion. All voted aye and the meeting adjourned at 3:02pm.
