# Motor Fuel Gallons Purchased by In-State and Out-of-State Users

### Gasoline

We estimate that vehicles in South Carolina use an estimated 1,932,473,409 gallons of gasoline based upon data from the S.C. Department of Motor Vehicles and the U.S. Department of Transportation. This was the product of the total number of registered vehicles in South Carolina and an estimated average number of gallons of gasoline used per vehicle. A total of 2,559,307,000 gallons of gasoline were purchased based upon gasoline user fee collections as reported by the S.C. Department of Revenue. Of this total, we estimate that 75.51 percent of gasoline was purchased by in-state residents, with the remaining 24.49 percent being purchased by out-of-state residents.

#### Diesel

Out-of-state users account for an estimated 312,150,554 gallons of diesel fuel purchased in South Carolina. This estimate is derived from two sources. The S.C. Department of Motor Vehicles International Fuel Tax Agreement Report documented 294,354,279 gallons of taxable diesel fuel gallons were purchased by out-of-state motor carriers. An estimated additional 17,796,275 gallons were purchased by out-of-state passenger vehicles. These purchases by out-of-state users compared to the total of 657,030,593 gallons of diesel fuel purchased in South Carolina result in an estimated 47.51 percent of diesel fuel being purchased by out-of-state users, with the remaining 52.49 percent being purchased by South Carolina users.

#### **Total**

The estimated gallons of gasoline and diesel fuel purchased by in-state users were totaled to estimate a weighted average of the total motor fuel gallons purchased by South Carolina residents. Of the total 3,216,337,593 gallons of motor fuel purchased, an estimated 2,277,353,448 were purchased by South Carolina residents. Based upon this analysis, an estimated 70.81 percent of total motor fuel is purchased by South Carolina users, with the remaining 29.19 percent being purchased by out-of-state users.
