WIRELESS 9-1-1 PROGRAM UPDATE

- Status of the NG9-1-1 procurement process
- Interactive NG9-1-1 fiscal model demonstration



NG9-1-1 FISCAL MODEL

Key Factors

- Fiscal model based on the calendar year
- Revenue forecasts assume an average annual growth rate of close to 2% over the next ten years
- Distribution projections:
 - Anticipate more accurate estimates for NG9-1-1 costs
 - Account for cost offsets between the State and the locals
- Managing the fund balance:
 - Wireless fee adjustments
 - Reimbursement rate adjustments (cost offsets)



NG9-1-1 FISCAL MODEL

MONITORING THE FUND'S PERFORMANCE

- Fund activity through June*:
 - Collections were 1% above projections
 - Distributions were on pace with projections
- Fund activity through September*:
 - Collections were 2.5% above projections
 - Distributions were 3% below projections

*annualized year-to-date totals



ADOPTION OF WIRELESS FEE FOR 2020 (§23-47-50(F))

Recommendation to maintain the wireless fee at \$0.62 for the calendar year 2020

QUARTERLY REVIEW HIGHLIGHTS

CUSTOMER FOCUS

- The certified boundary between Laurens and Greenville counties became effective August 5, 2019
- Property owners affected by the Horry/Georgetown boundary clarification project filed an annexation application with the Governor requesting to remain in Horry County. As a result, a referendum vote was held on November 5, 2019 with an overwhelming majority voting in favor of the annexation to remain in Horry County
- Other boundary projects currently in process include field work completed in the following counties:
 - Berkeley/Charleston
 - Charleston/Dorchester
 - Darlington/Florence
 - Lancaster/Kershaw
 - York/Chester
 - Newberry/Union



QUARTERLY REVIEW HIGHLIGHTS

WORKFORCE DEVELOPMENT

- Staff completed 522 training hours; topics included:
 - Advanced Excel
 - Web Security
 - Advanced Supervisory Practices
- Implemented an online confidential employee exit survey
- Four positions were vacated and reviewed



QUARTERLY REVIEW HIGHLIGHTS

CONTINUOUS IMPROVEMENT

- Convened a cross-divisional census team to discuss the upcoming 2020 Census and to more efficiently coordinate the census related activities of the office
 - Identified roles lacking secondary contacts
 - Developed plan to address gaps through cross-sectional training

Results for America

- Mission: Make investing in what works the "new normal," so that when policymakers make decisions, they start by seeking the best evidence and data available, then use what they find to get better results
- *Invest in What Works State Standard of Excellence* sets a national standard for the effective use of evidence and data by state governments in budget, policy, and management decisions to achieve better outcomes for citizens
 - South Carolina (RFA) was identified as a promising example of data use in the 2019 State Standard of Excellence
 - Our goal is to become a leading example of data use or a promising example in another area



NATIONAL BENCHMARKS

Actionable Intelligence for Social Policy (AISP)

- AISP is an initiative that focuses on the development and use of integrated data systems (IDS) for policy and planning
- Goal: Help state and local governments leverage data to improve lives
- Services: Work to develop the capacities of existing and new IDS sites, demonstrate uses of IDS for policy and program reforms, and identify opportunities for innovation in the development and use of IDS
 - South Carolina (RFA) is cited as a best practice case study
 - Our goal is to find other opportunities for growth and recognition of South Carolina's Integrated Data System
 - AISP reached out to us recently on behalf of the Bill and Melinda Gates Foundation
