- I. Chairman Grimball called the meeting to order at 1:52 p.m.
- II. Chairman Grimball presented the August 26, 2021 and meeting minutes which previously had been shared with the Members and asked if any Member had edits or questions. Hearing no amendments or objections, Chairman Grimball declared the minutes approved as written. (see minutes)

III. Employee Recognition

On behalf of the agency, Mr. Rainwater recognized the following individuals for their years of service and presented those attending in person with a certificate:

IV. Agency Matters

Mr. Rainwater introduced the agency presenters and provided a brief summary of the topics of the meeting.

- Frank Rainwater presented the proposed Organizational Structure which combines the agency GIS departments under Adam DeMars and moves Compliance under Sandra Kelly. (see materials)
 - Mr. Gower made a motion to approve the organizational structure and Mr. Clemmons seconded the motion. All voted aye and the agency's organizational structure was approved.
- David Morrison presented the Statewide NG9-1-1 Implementation Progress Report. (see materials)
 - 5 PSAPs (Public Safety Answering Points) have successfully migrated to the statewide ESInet and these first transitions have provided

invaluable lessons learned in regards to the onboarding schedule and process.

- Paul Athey presented the 9-1-1 Fiscal Model Analysis. (see materials)
 - A fund balance of over \$41 million is anticipated beginning calendar year 2022 which updates the fiscal model and would allow the option to only have to reduce the reimbursement percentage once to 70% in 2027, allowing time for all PSAPs to join the new ESInet paid for by the state if we were to increase the wireless fee to \$0.64 two years sooner in 2023.
 - There is a possibility of Federal Grant Funding as part of the Budget Reconciliation Act:
 - In 2019, South Carolina was awarded a federal grant which represented 2.14% of the total funding. If South Carolina were to receive 2.14% of this proposed federal funding that would equal \$214 million which would completely change everything in our current fiscal model. This is a very big "if" so our recommendation is to continue to monitor the grant very closely but continue with business as usual.

Chairman Grimball thanked Mr. Athey for his presentation and asked members if further discussion was needed prior to the adoption of the wireless fee for 2022 (§23-47-50(F)) and continue the cost reimbursement percentage of the PSAPs at 80%. Mr. Gower made a motion to keep the wireless fee at the current rate of \$0.62 per month for the calendar year 2022 and keep the cost reimbursement at 80% for 2022. Mr. Clemmons seconded the motion and all voted aye.

Members commented on the information presented and asked questions which generated further discussions between Members and staff.

Chairman Grimball, Mr. Clemmons, and Mr. Gower thanked staff for the effort put forth for the meeting.
