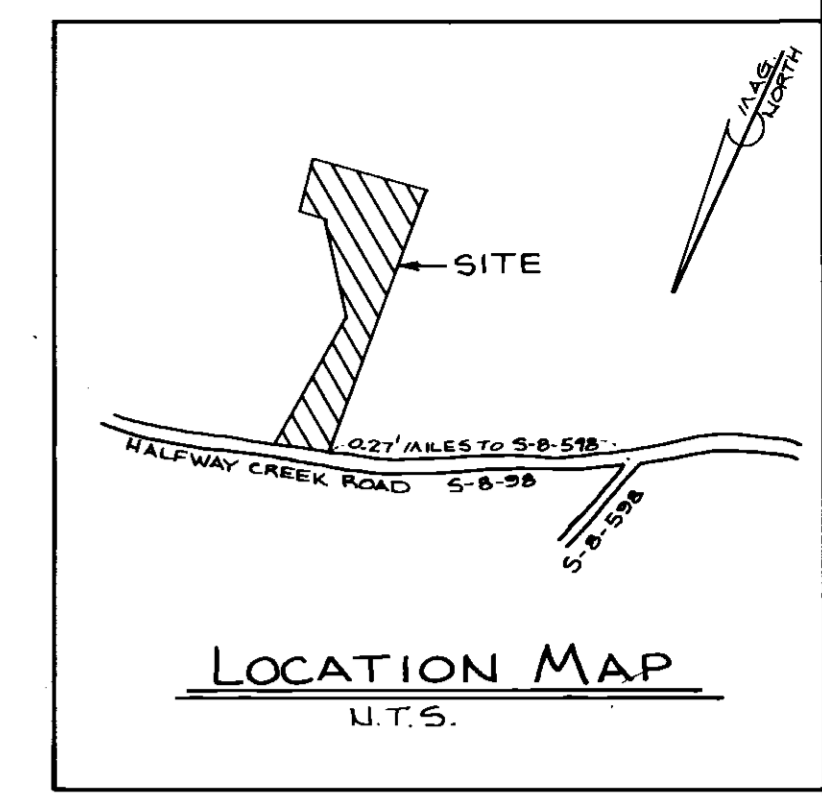

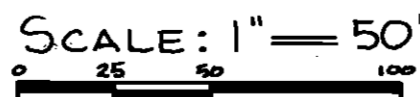


PLAT
