CORNER DESCRIPTIONS:

- CORNER 1 IS NEW IRON PIN AT 18" MAPLE, W. BANK. 8" IRONWOOD BEARS S41W 10'.
- CORNER 2 IS POINT ON WEST SHOULDER OF HWY. 26' FROM CENTER LINE. SET IRON PIN ON LINE N52-14E 34' FROM CENTER LINE.
- CORNER 3 IS IRON PIN IN OLD ROAD BED, A FAIRFIELD CORNER.
- CORNER 4 IS POINT IN HWY. 56.
- CORNER 5 IS JUNCTION OF HWY. CENTER-LINES.
- CORNER 6 IS FAIRFIELD IRON PIN IN OLD ROAD.
- CORNER 7 IS POINT IN R/W 25' FROM CENTER-LINE. SET IRON PIN WITNESS S41-45E 6' FROM CORNER.
- CORNER 8 IS NEW IRON PIN. 16" S.GUM BEARS N30W 8', 14" S.GUM N77W 6', 5" ELM S18W 6'.
- CORNER 9 IS NEW IRON PIN AT DEAD POST OAK. 9" PINE BEARS N35W 9', 7" HICKORY S36E 21', 9" WATER OAK N61E 22'.
- CORNER 10 IS NEW IRON PIN. 6" POPLAR BEARS N28E 5', 9" POPLAR S75E 11', 3" S.GUM S20W 6'.
- CORNER 11 IS 4' WIDE WHITE OAK STUMP ON N. BANK OF BRANCH. 8" RED OAK N20E 15', 3" S.GUM S31E 7'.
