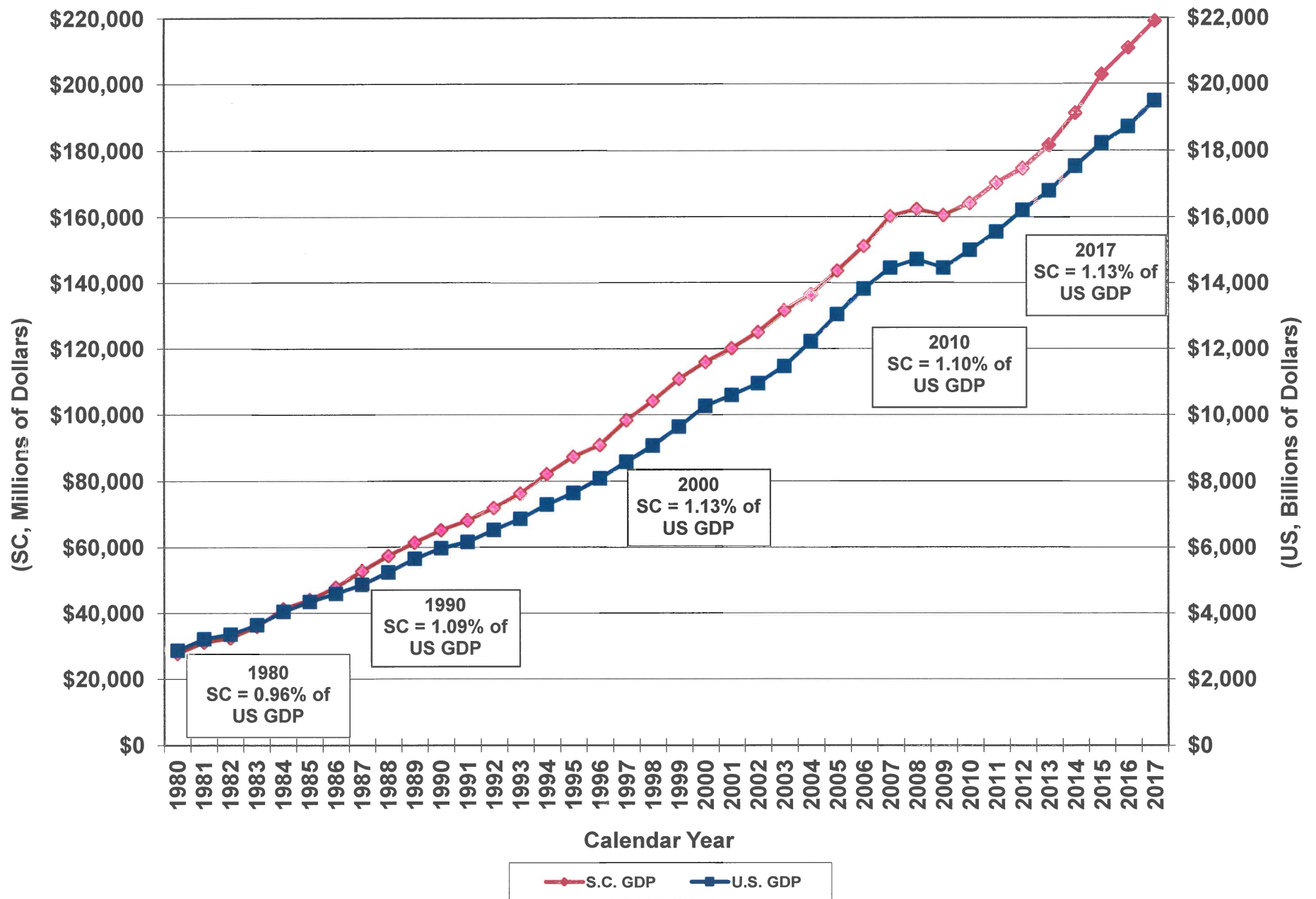

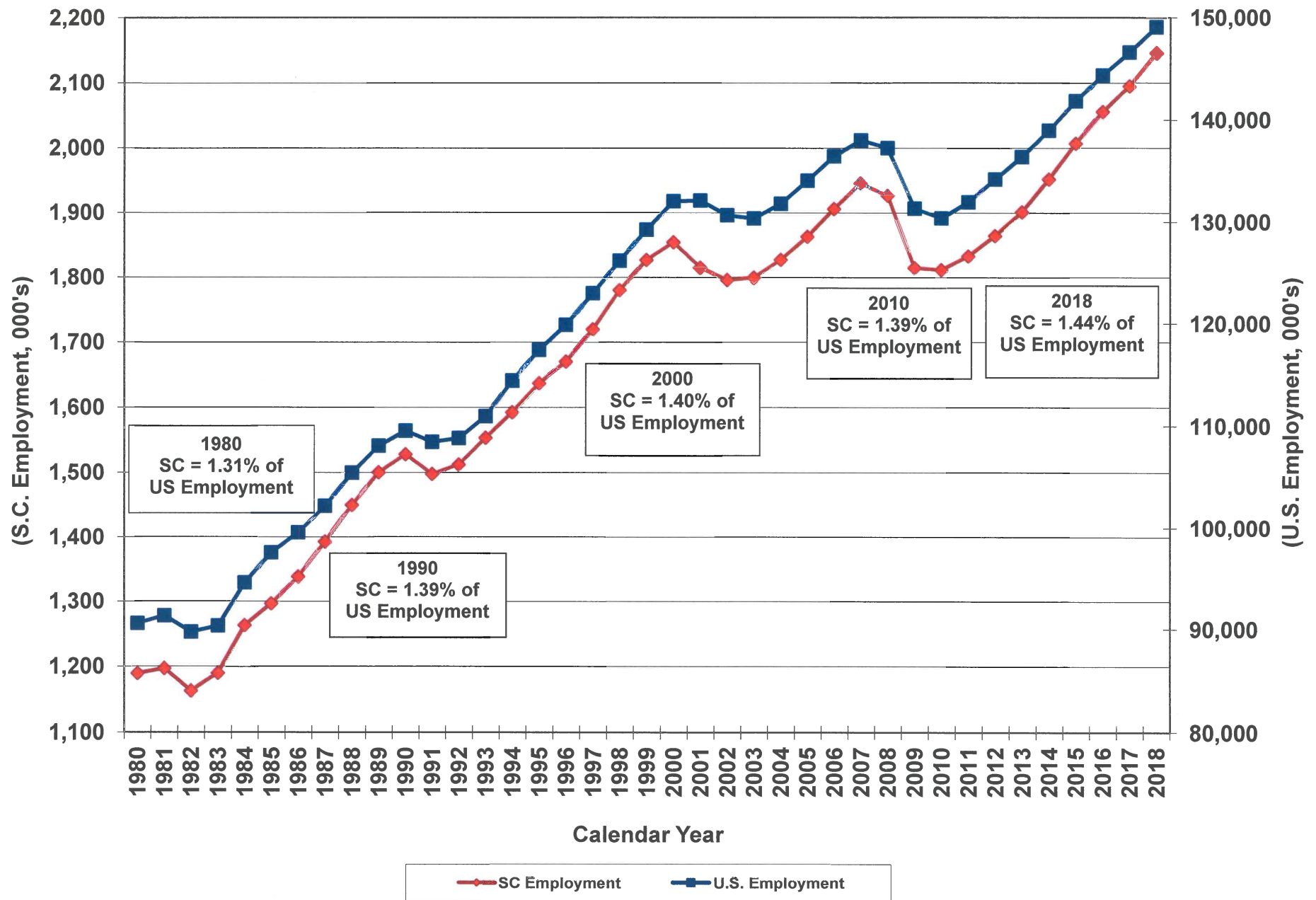

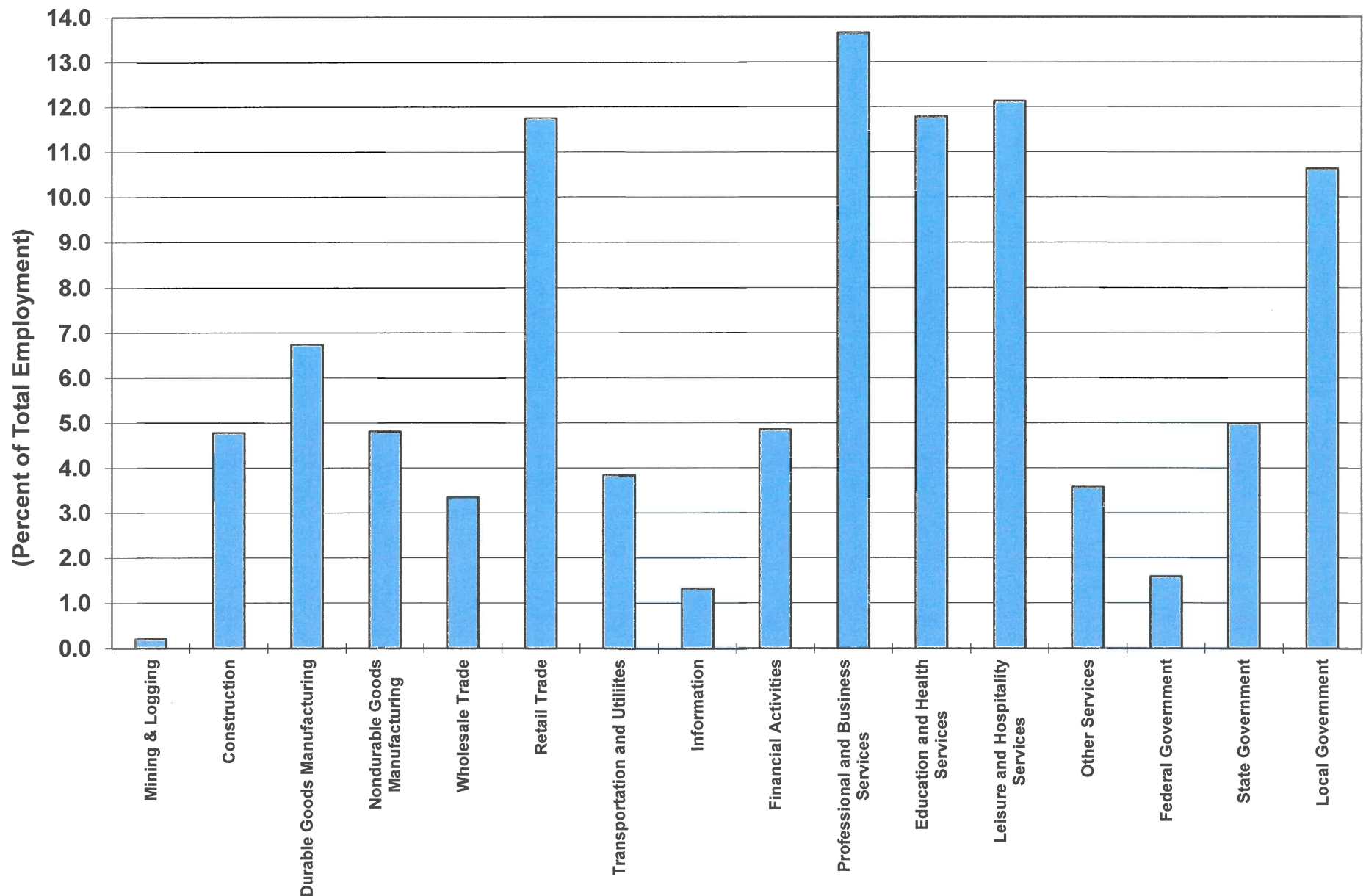
Gross Domestic Product in the United States and South Carolina



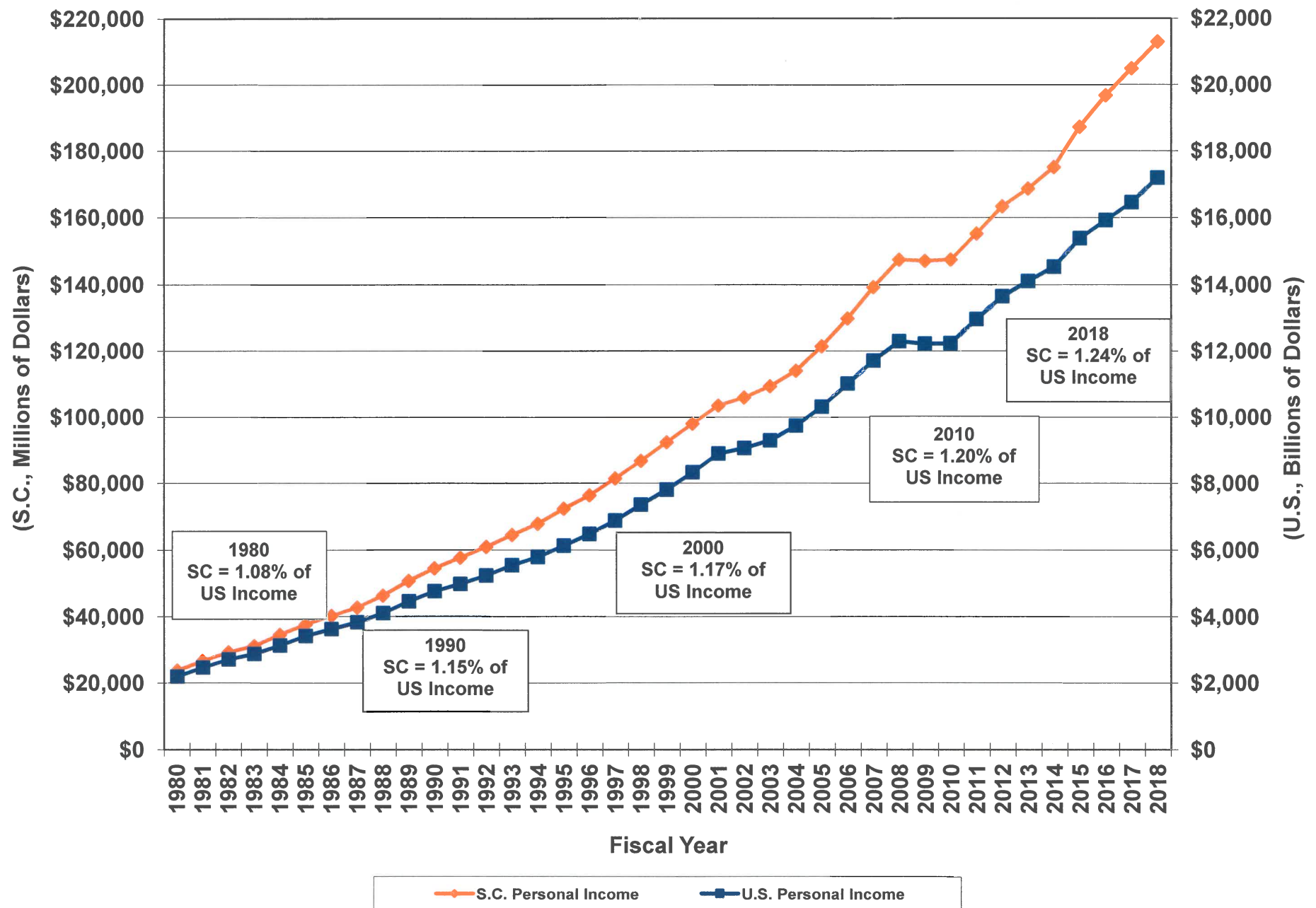
Total Nonfarm Employment in the United States & South Carolina



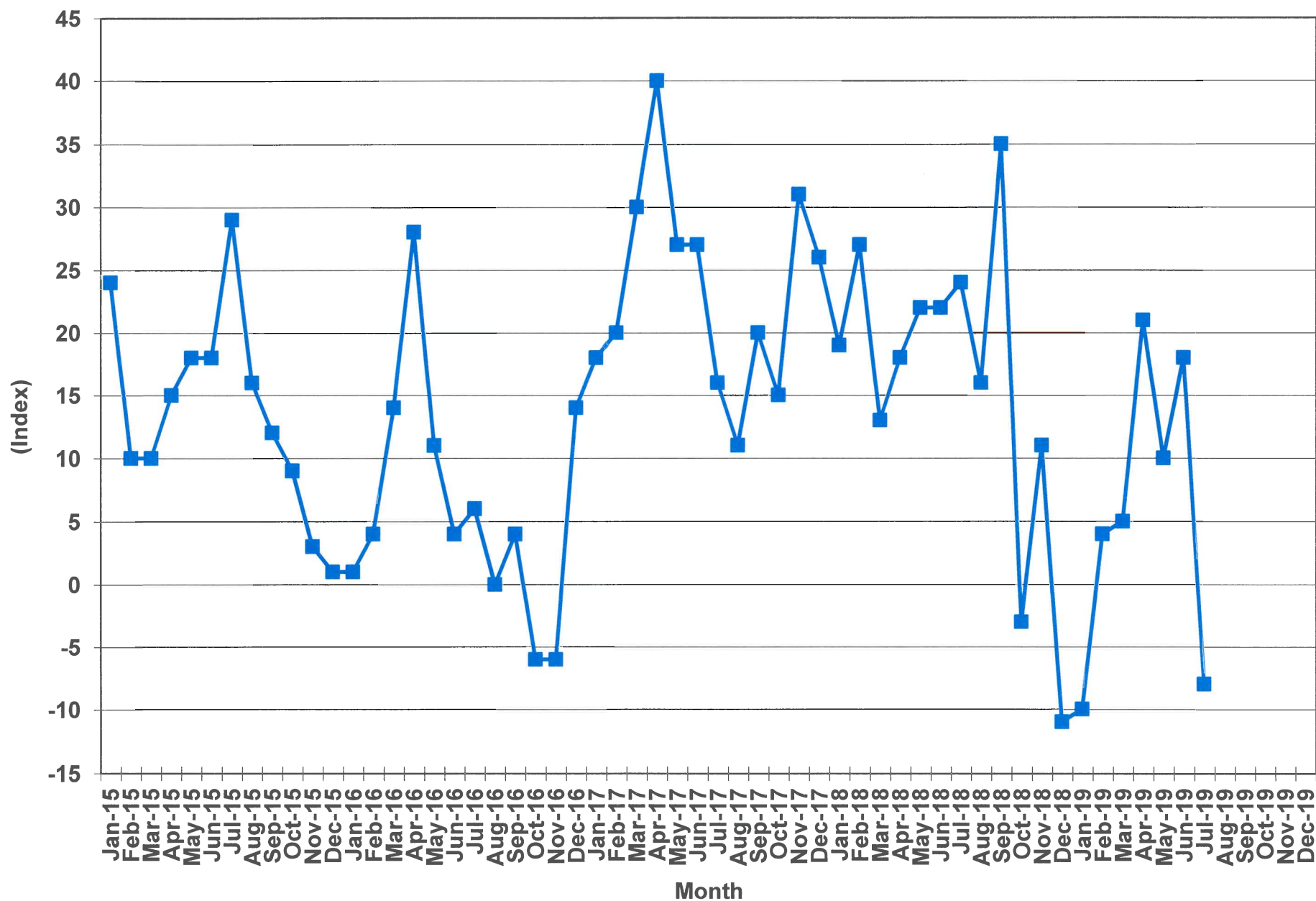
Share of South Carolina Nonfarm Employment By Sector Calendar Year 2018

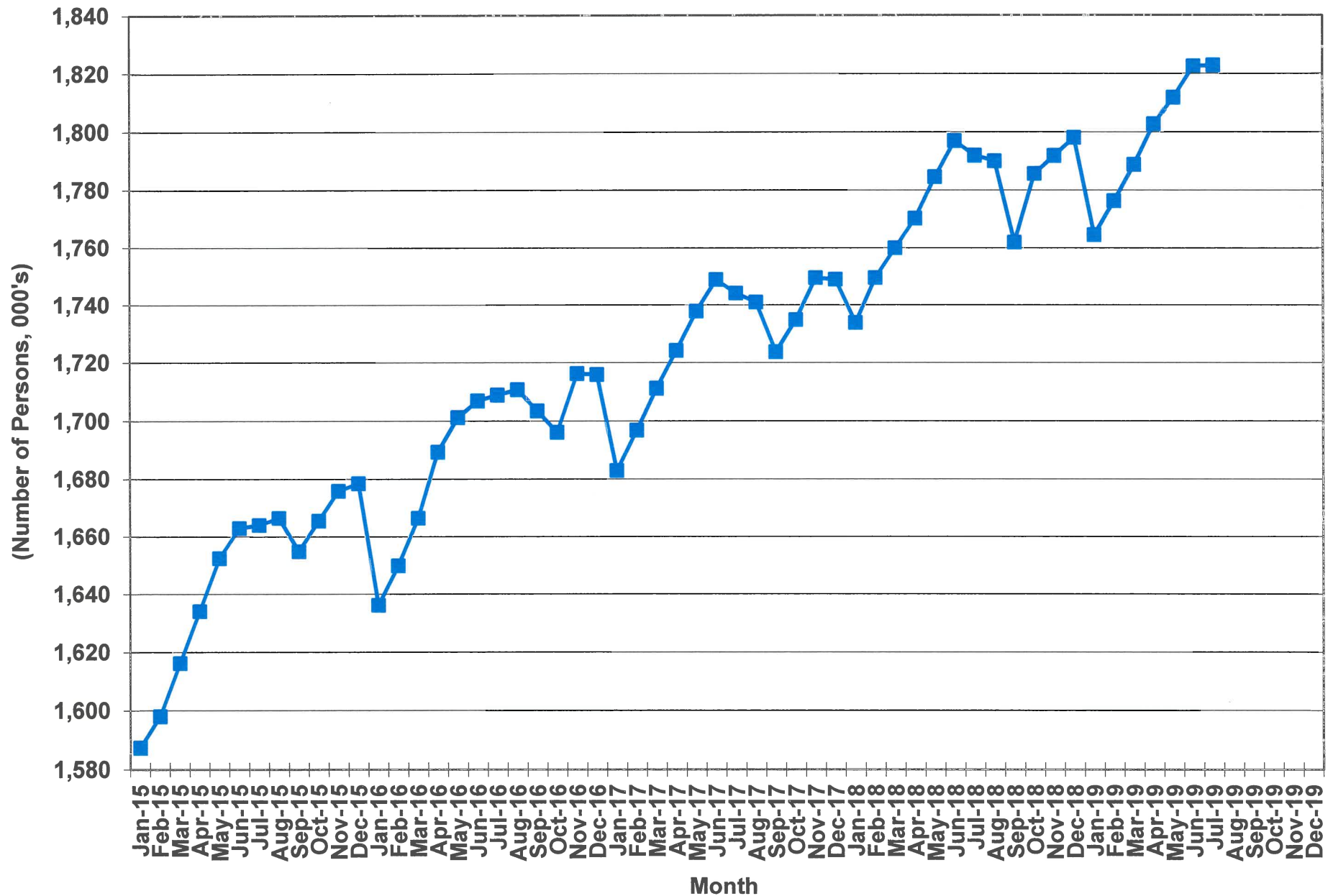
Total Nonfarm Employment Growth in South Carolina



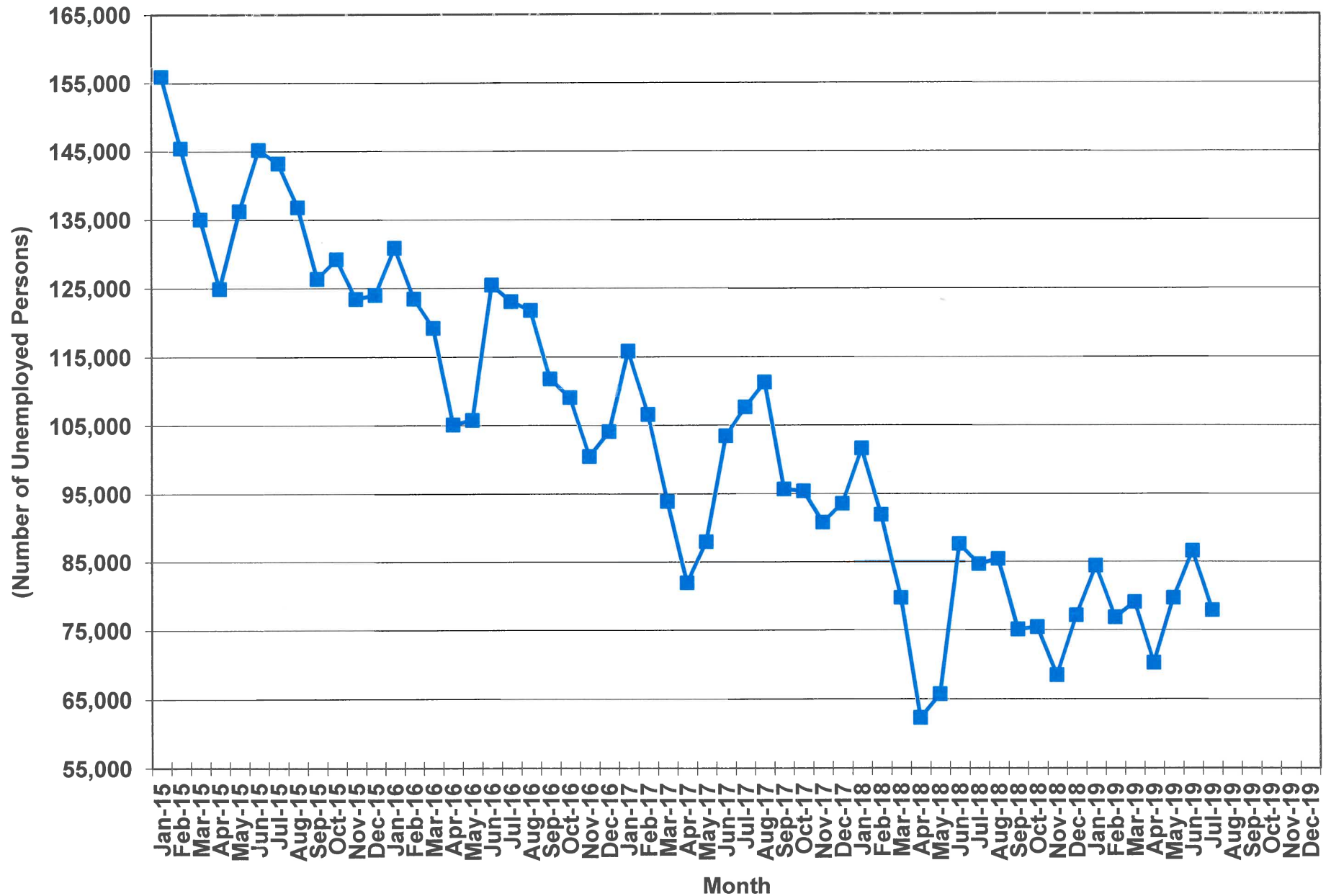
Net Nonfarm Employment Change in South Carolina



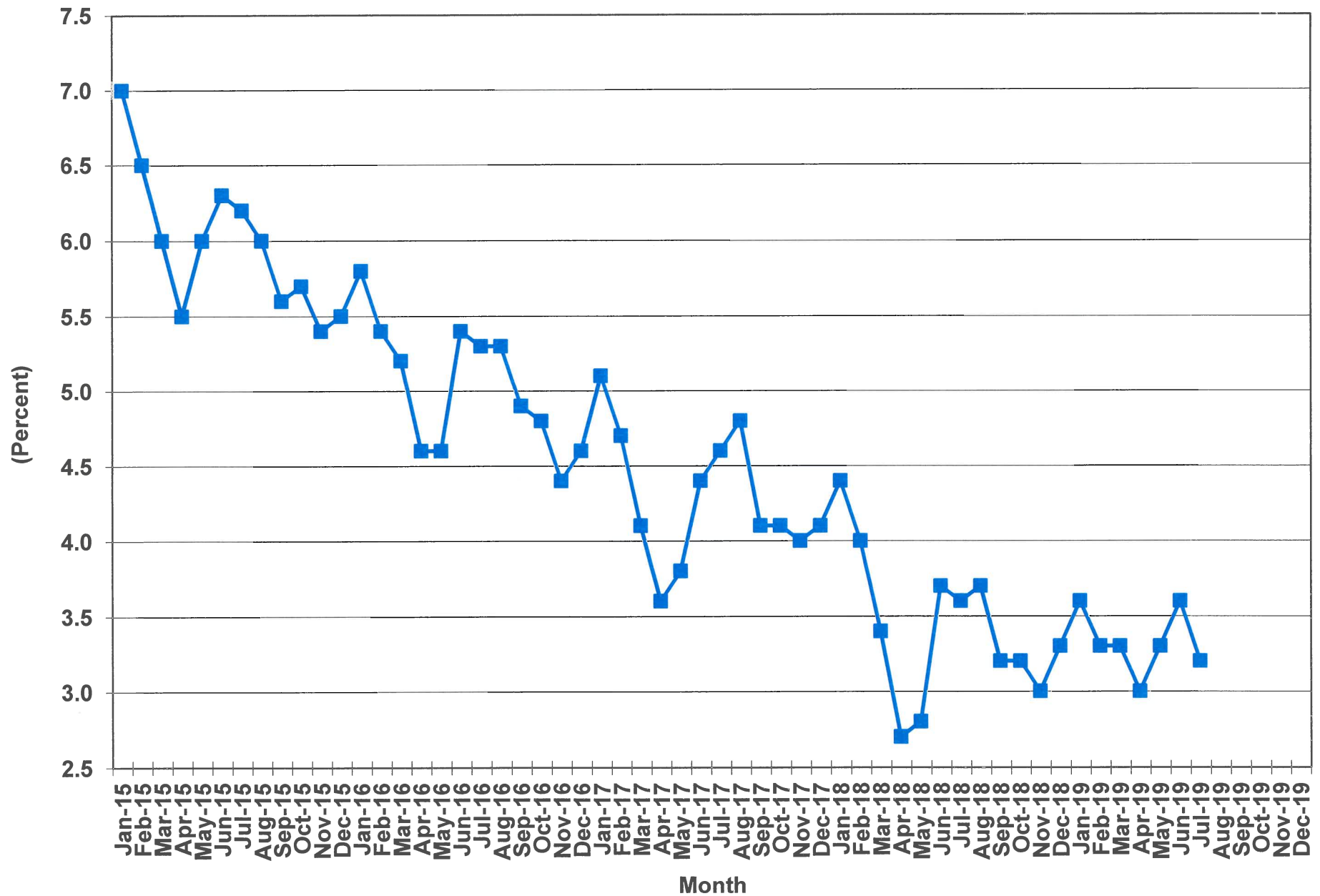

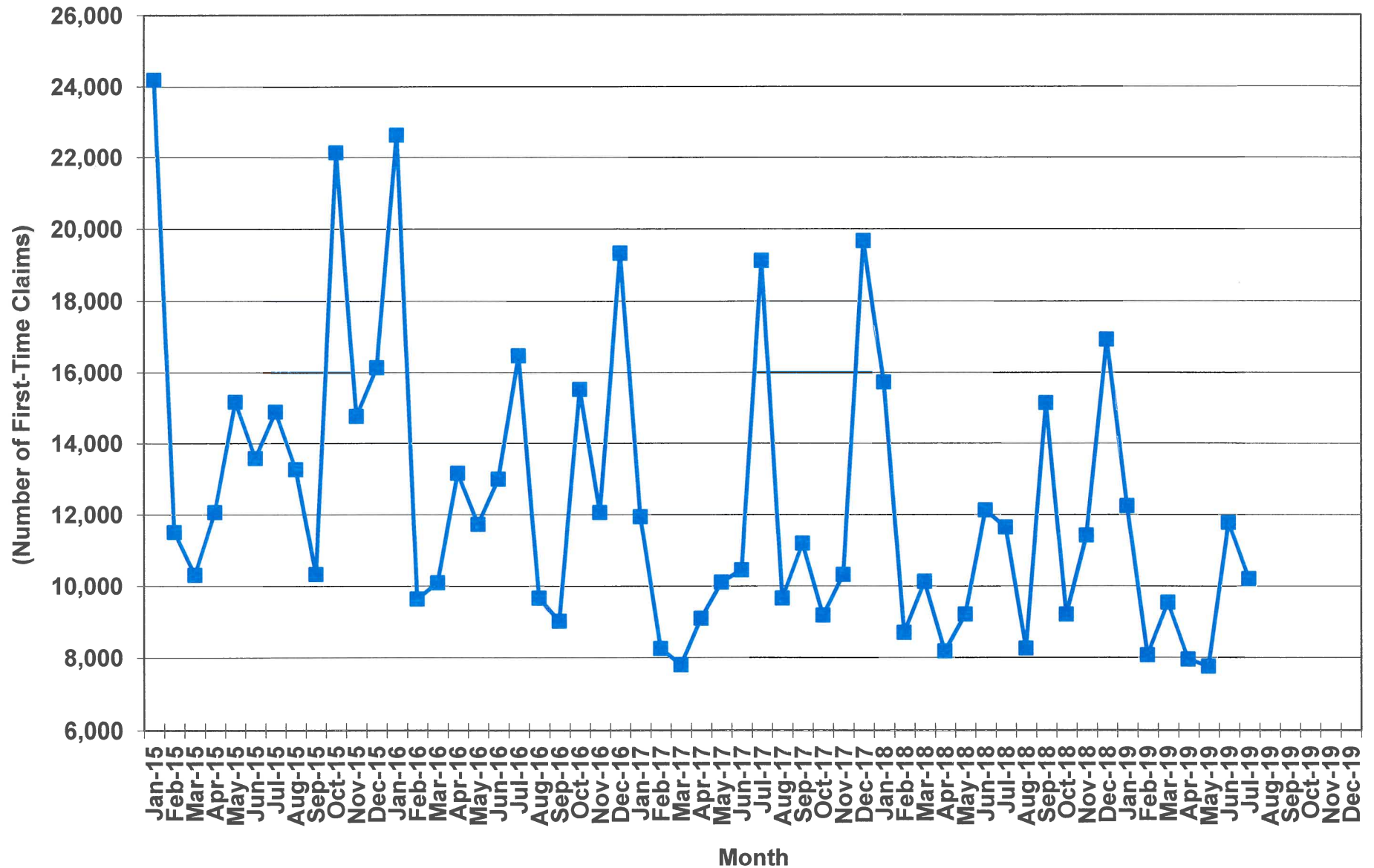
Change in the Labor Force in South Carolina



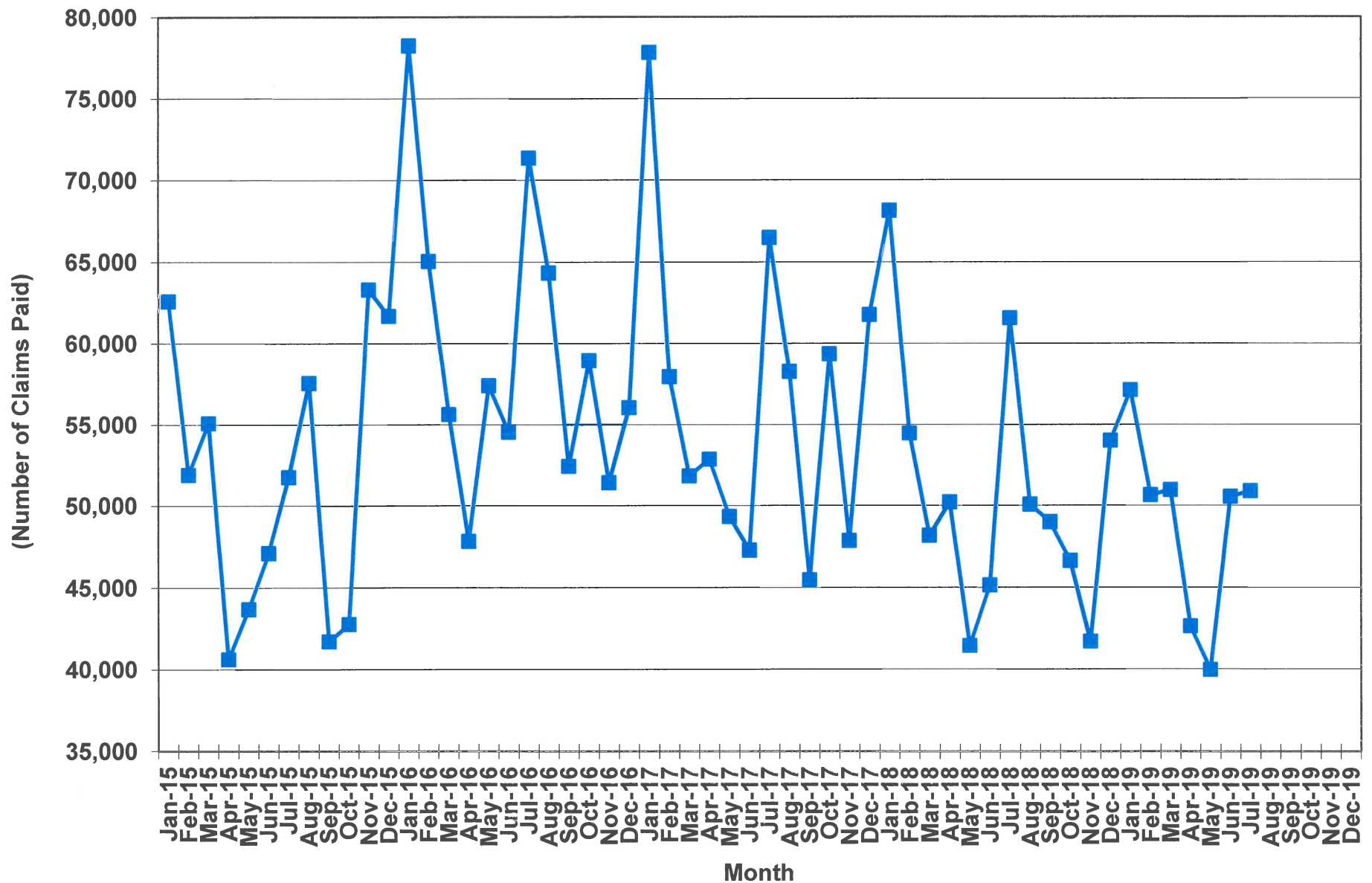
Civilian Labor Force Participation Rate in the U.S.



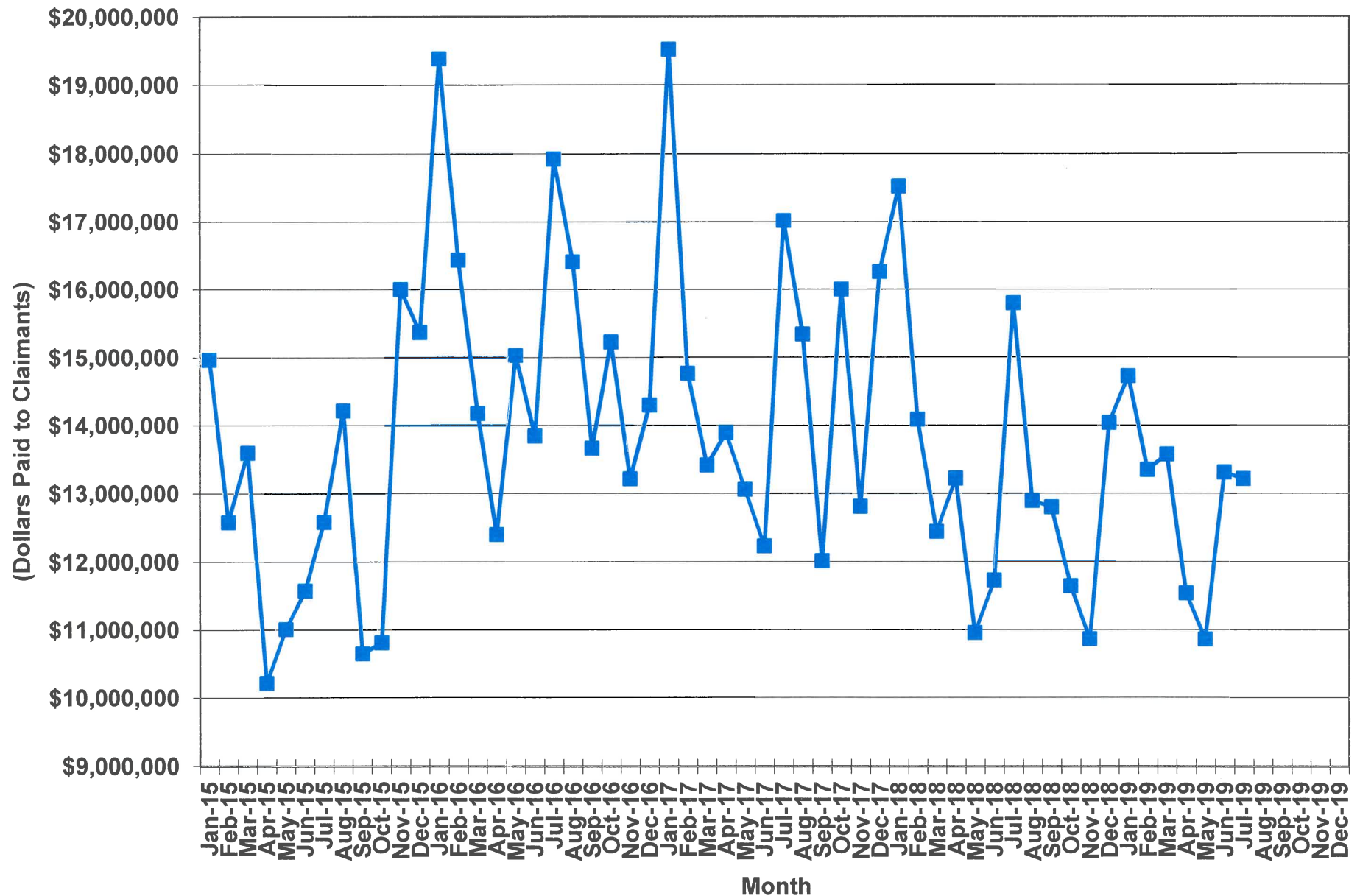
Initial Claims for Unemployment Insurance in South Carolina



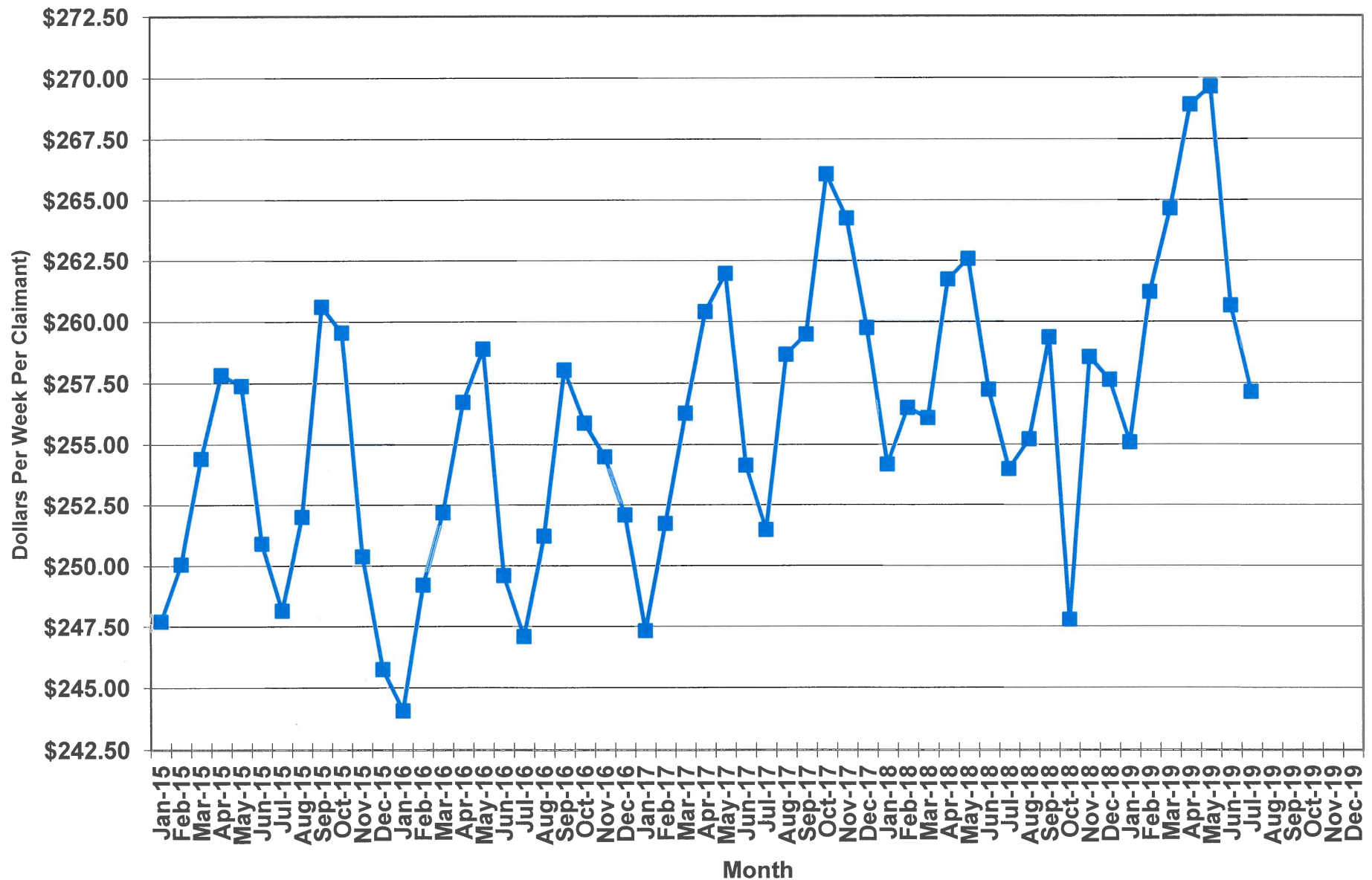
Total Number of Claims Paid for Unemployment Insurance in South Carolina

Average Weekly Benefit for Unemployment Insurance in South Carolina

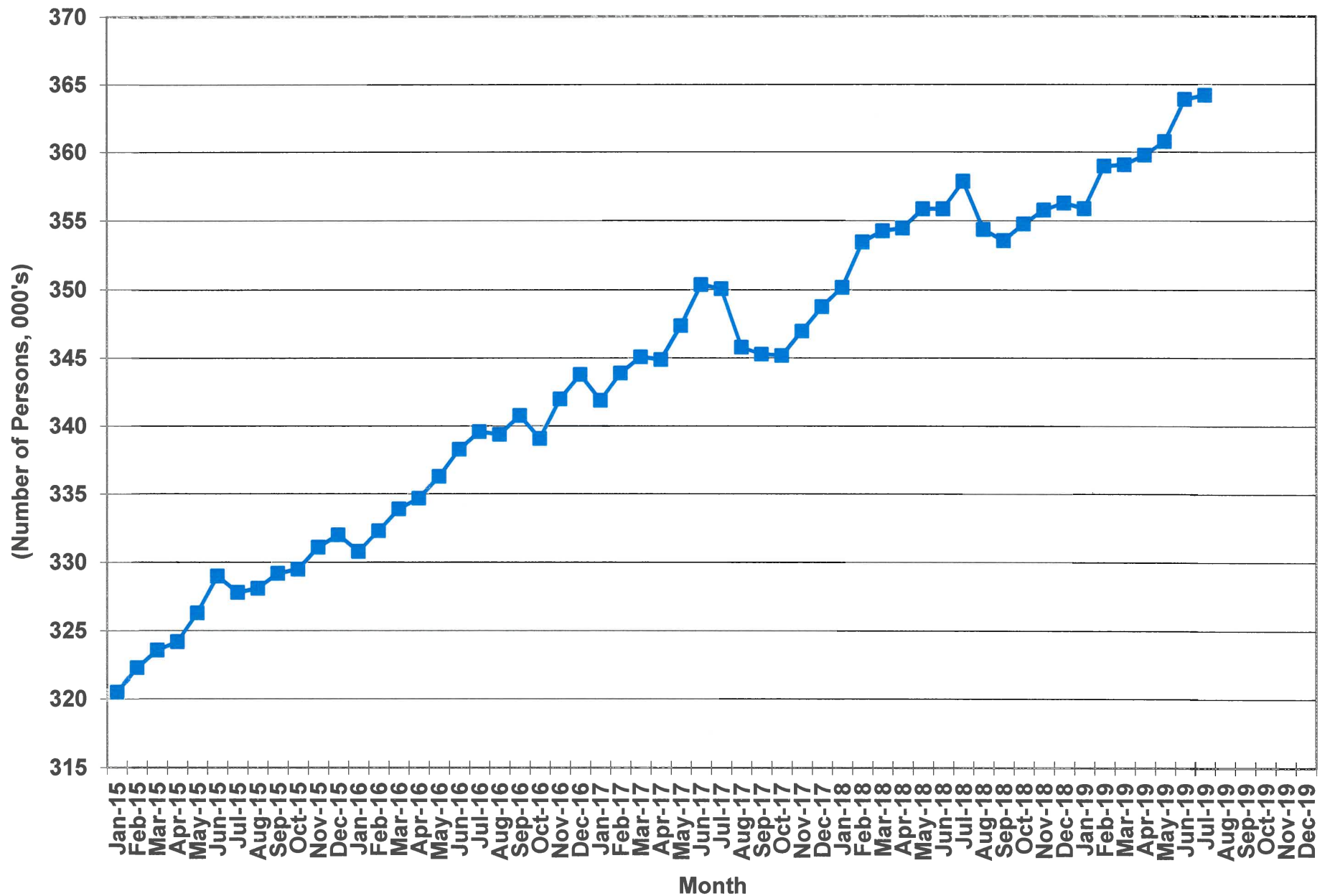

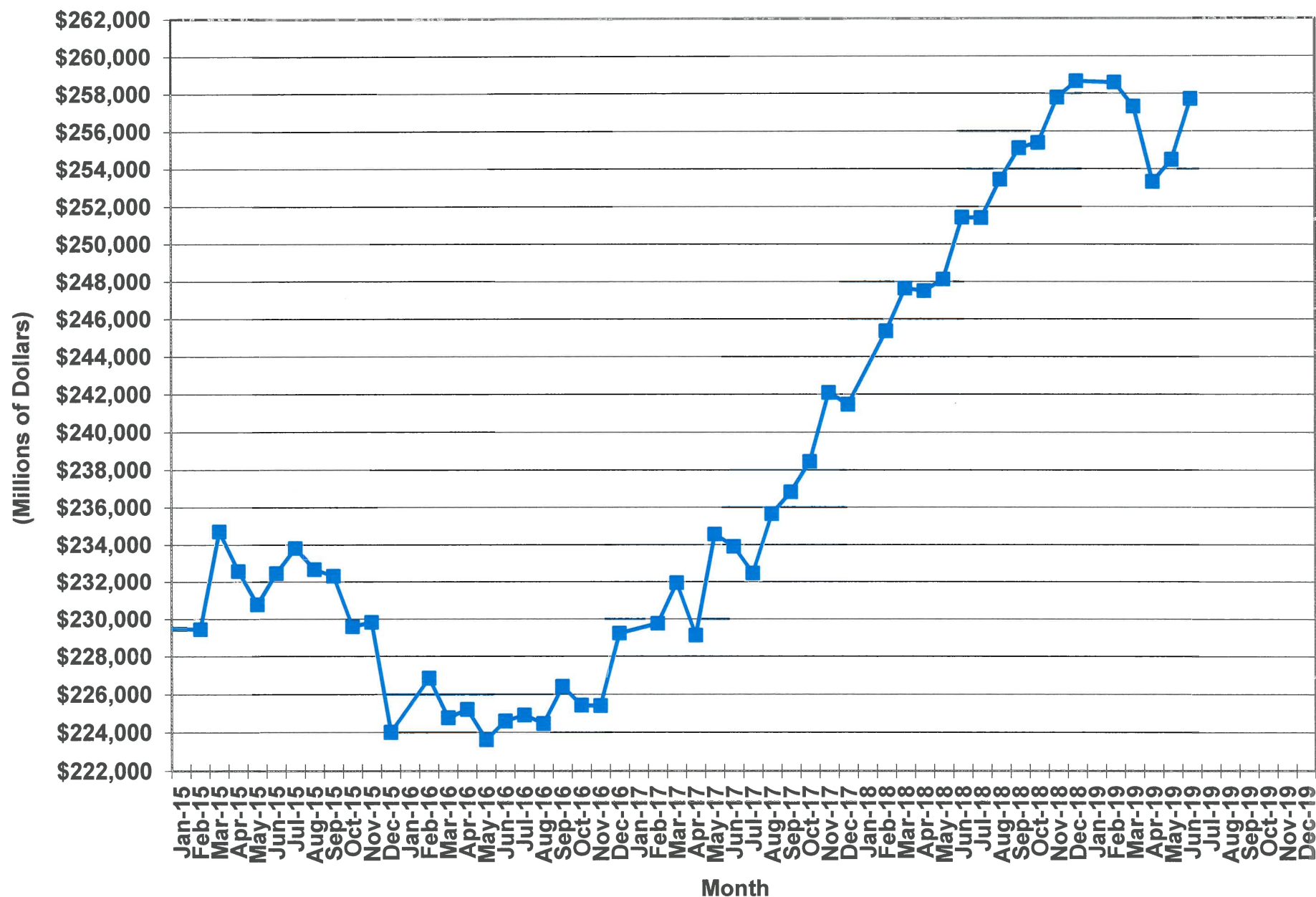
Average Work Week of Manufacturing Employees in South Carolina



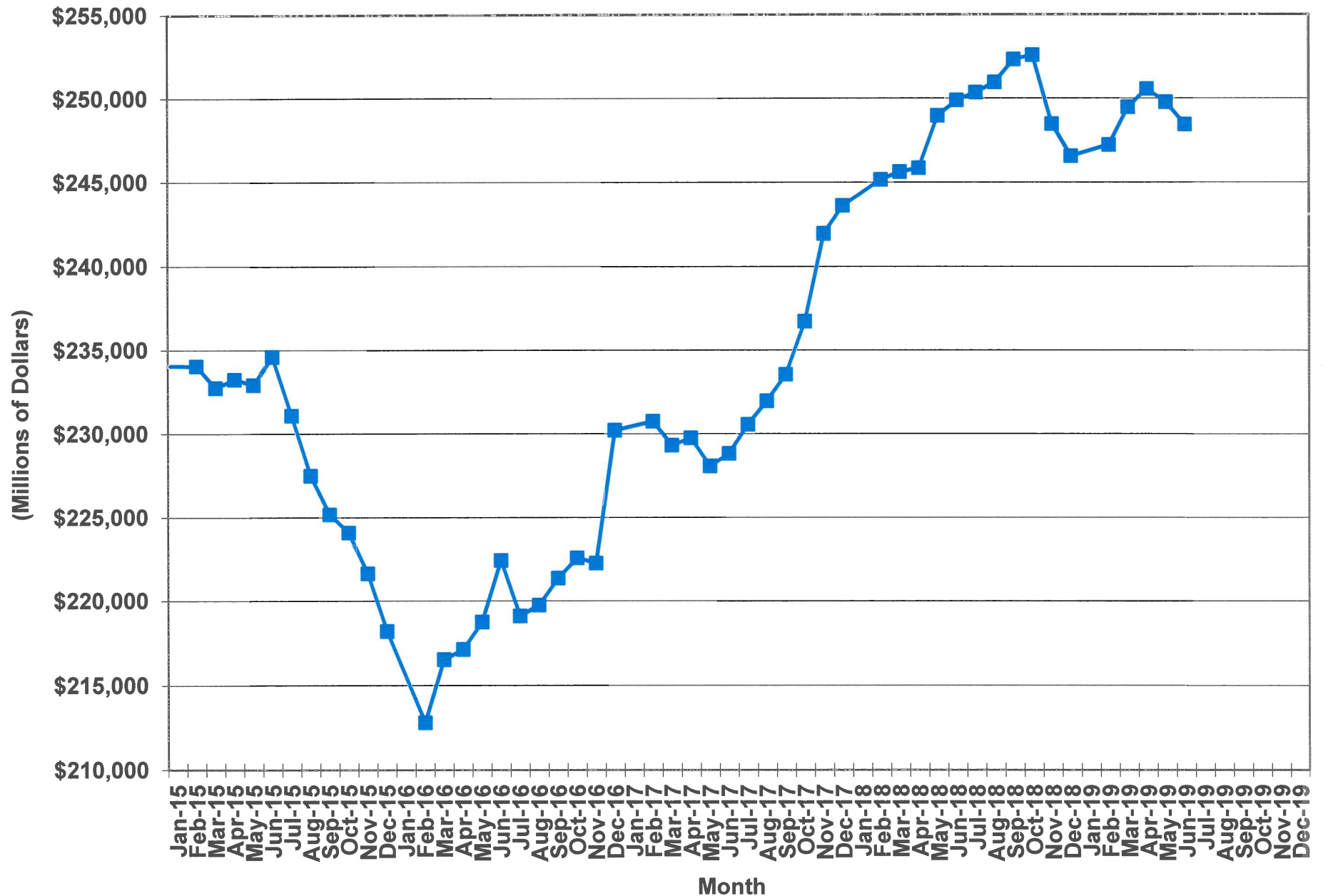

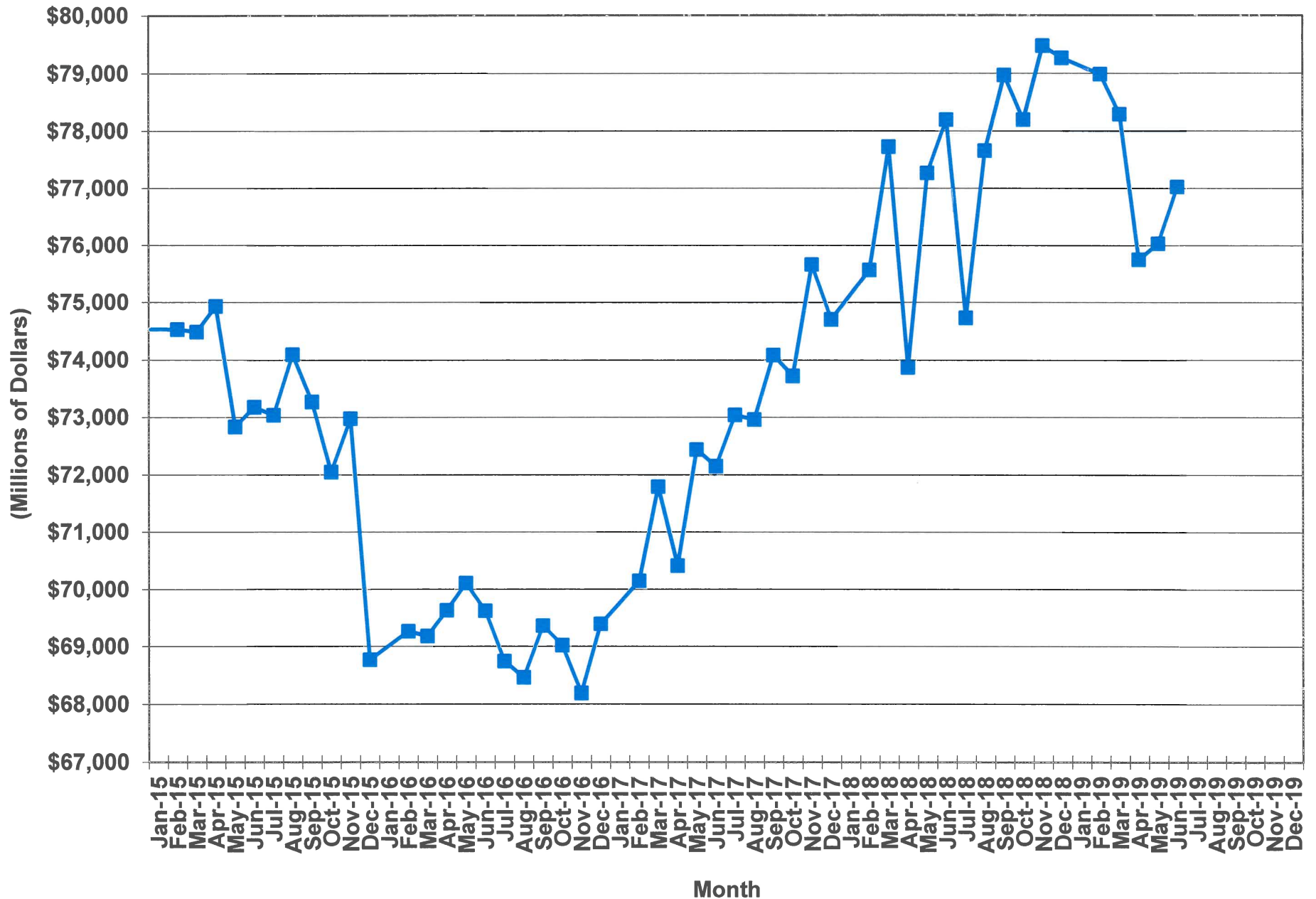
Manufacturer's Shipments of Durable Goods in the U.S.



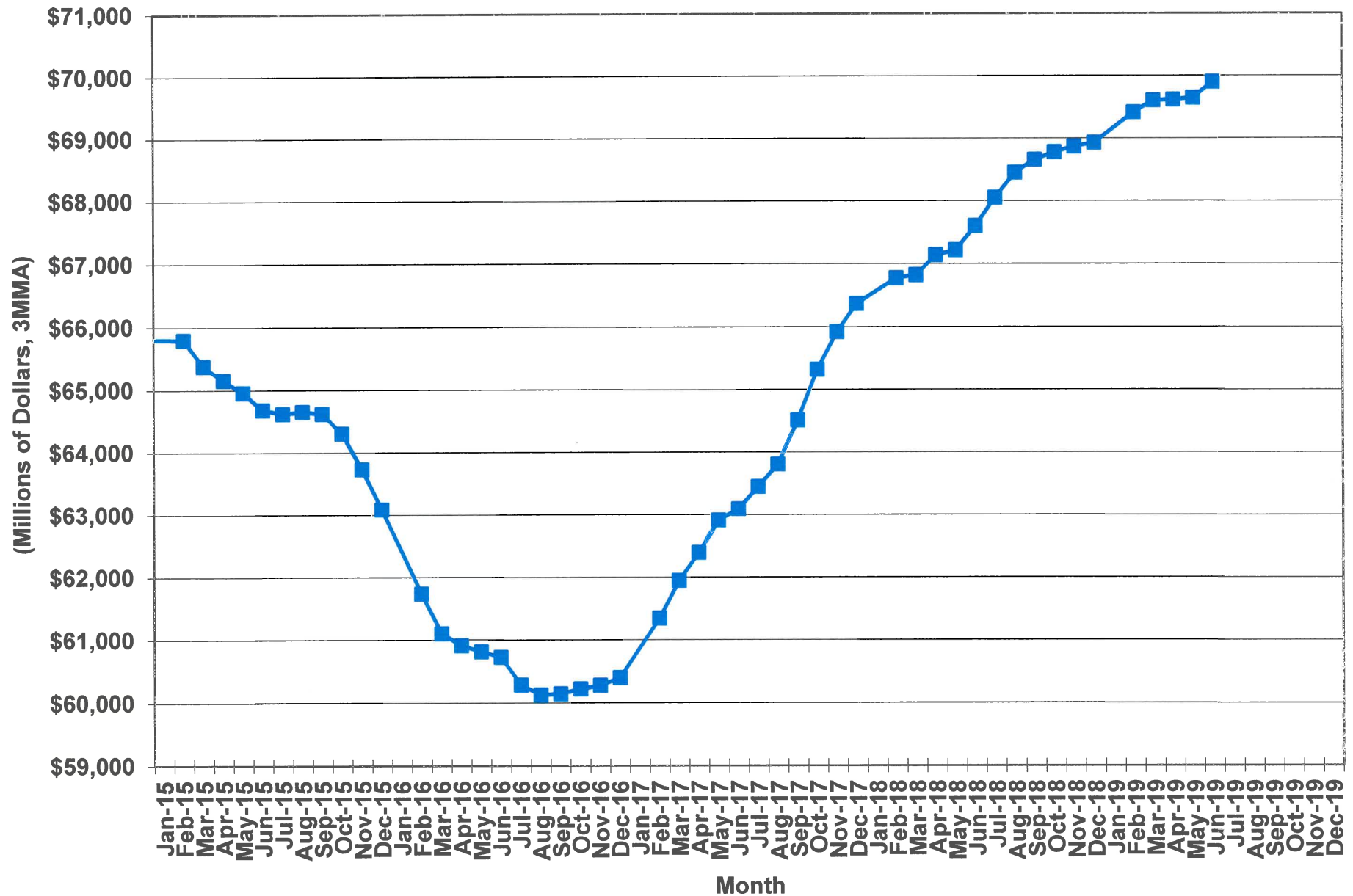
Manufacturer's Shipments of Nondurable Goods in the U.S.



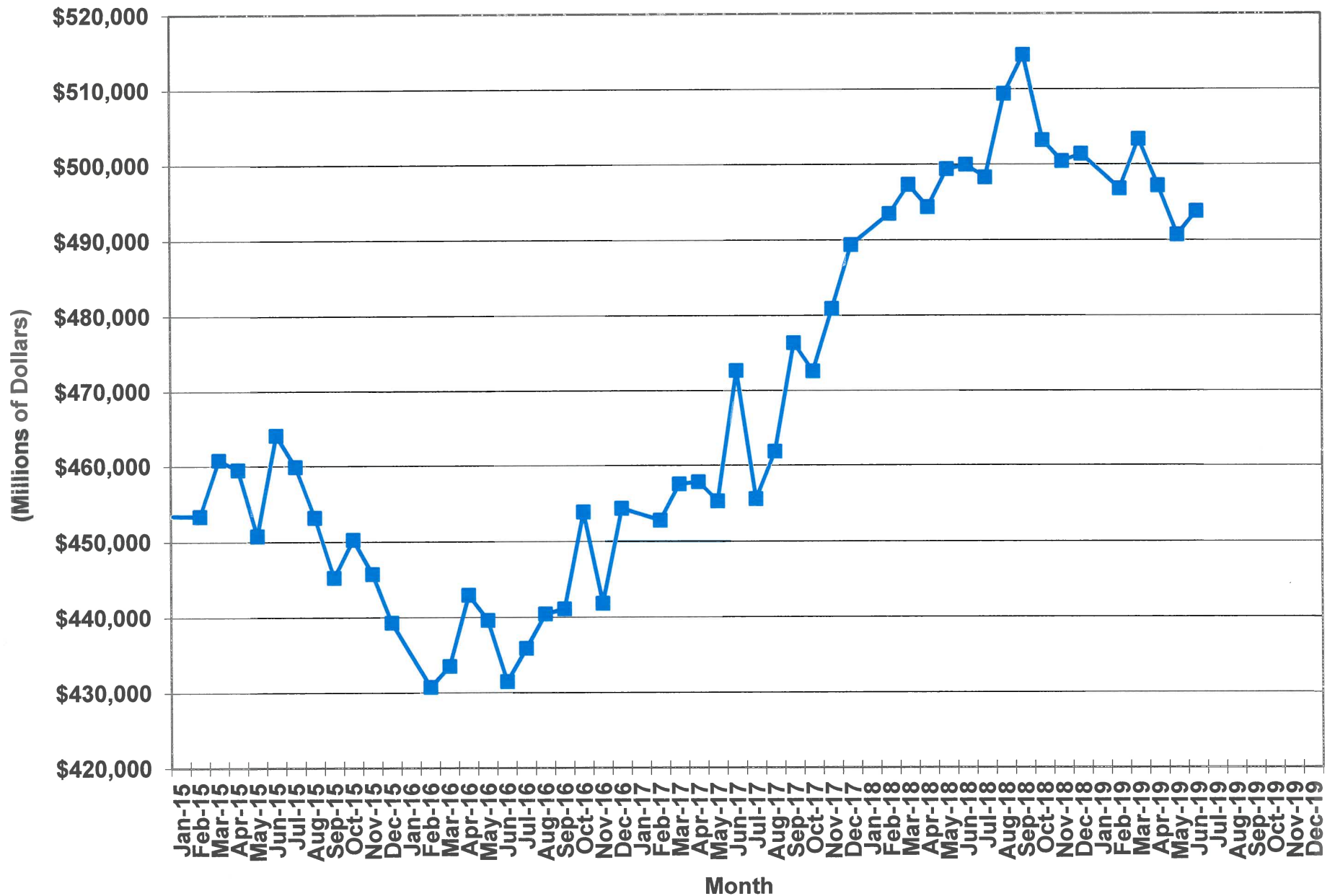
Total Manufacturer's Shipments of Nondefense Capital Goods in the U.S.



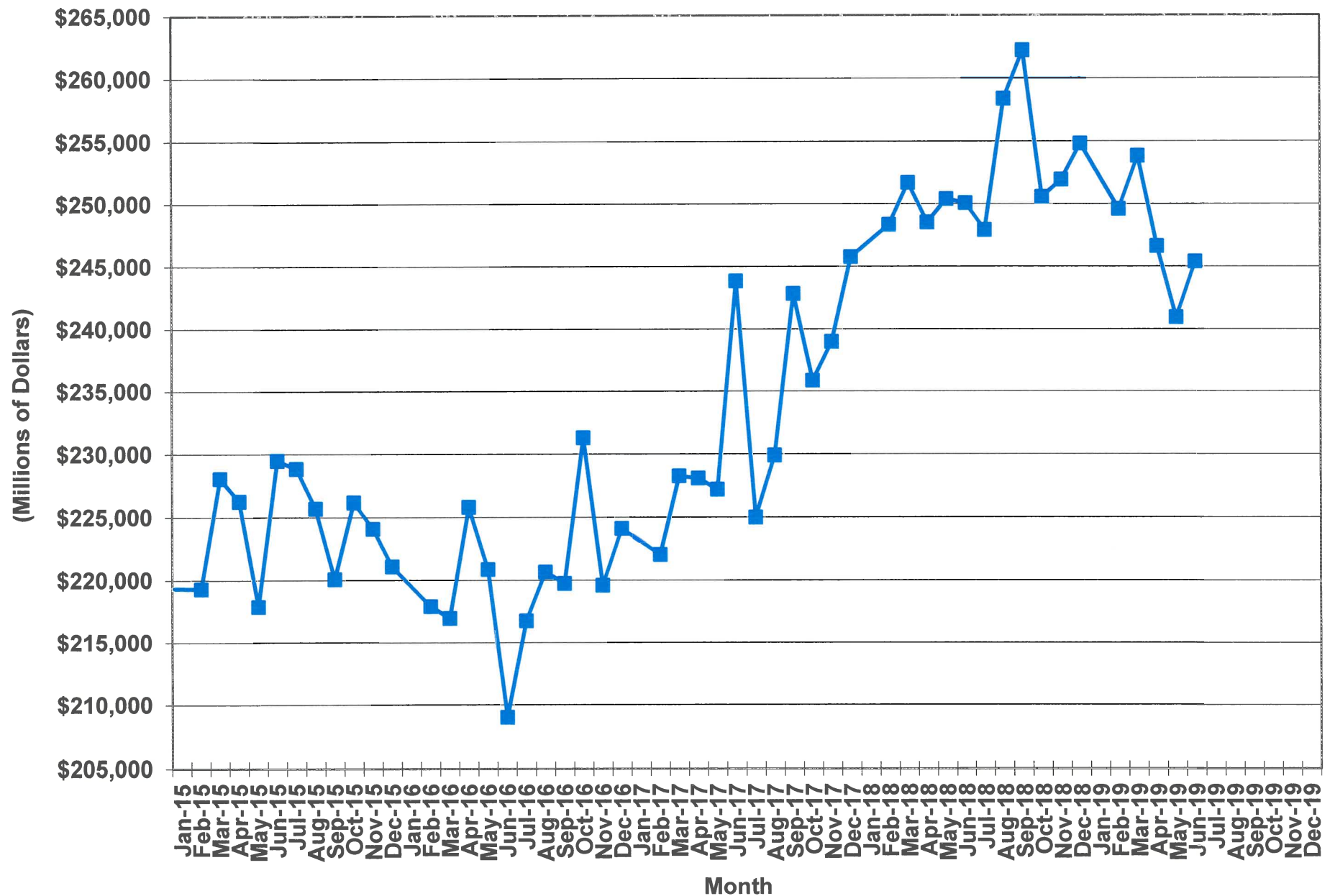
Total Manufacturer's Shipments of Nondefense Capital Goods Excluding Aircraft in the U.S.



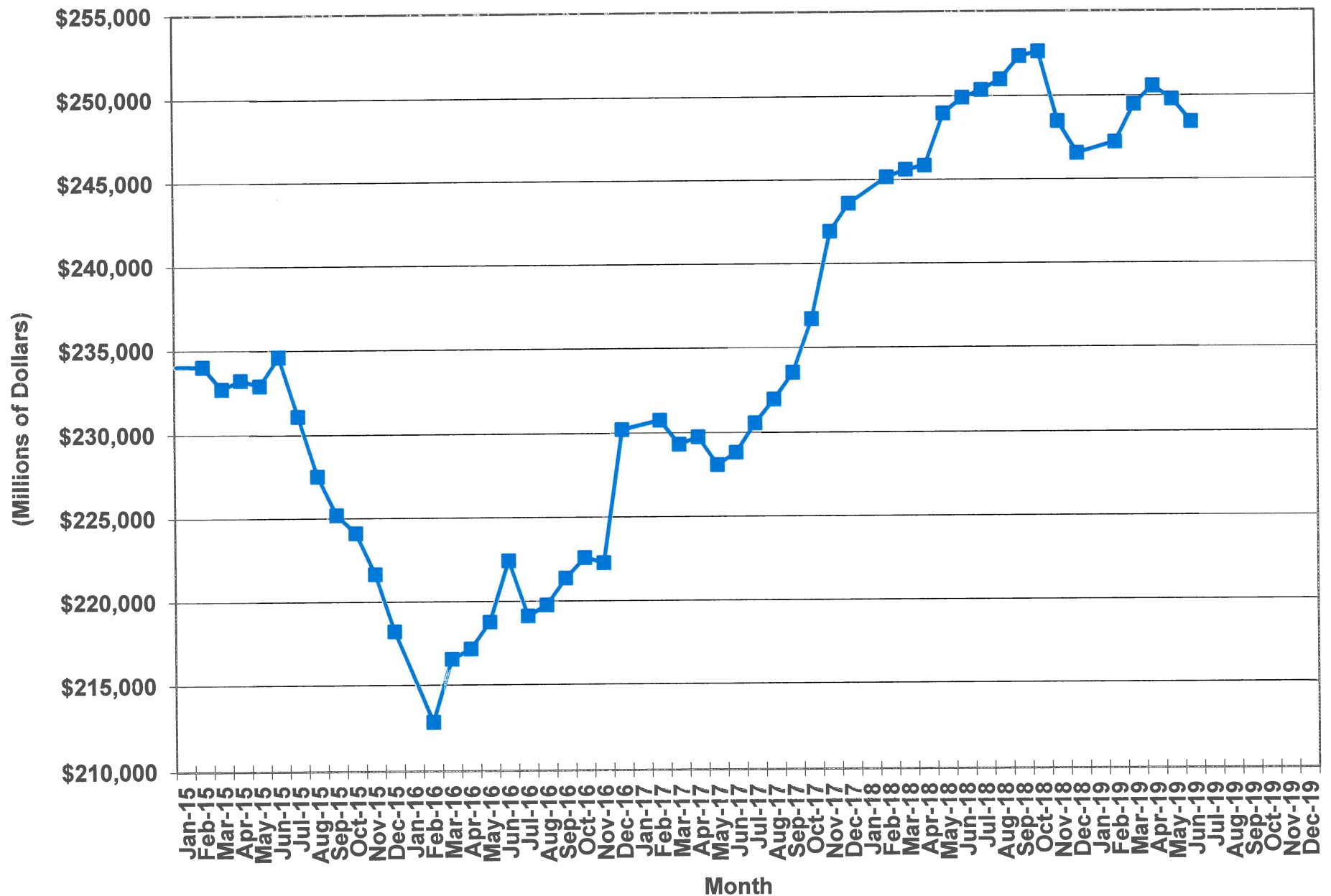
Total New Orders of Manufacturer's Goods in the U.S.



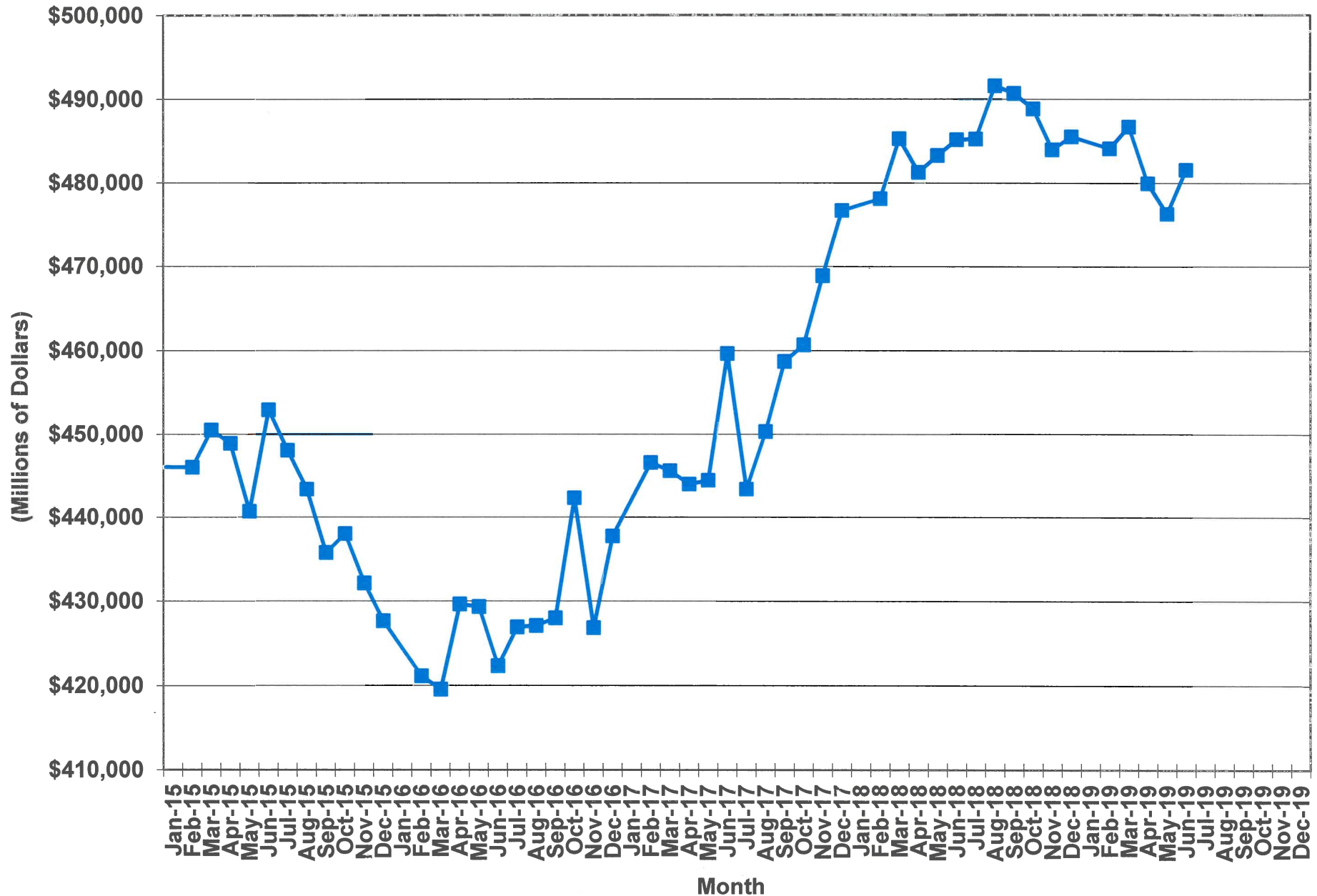
Total New Orders of Durable Goods in the U.S.



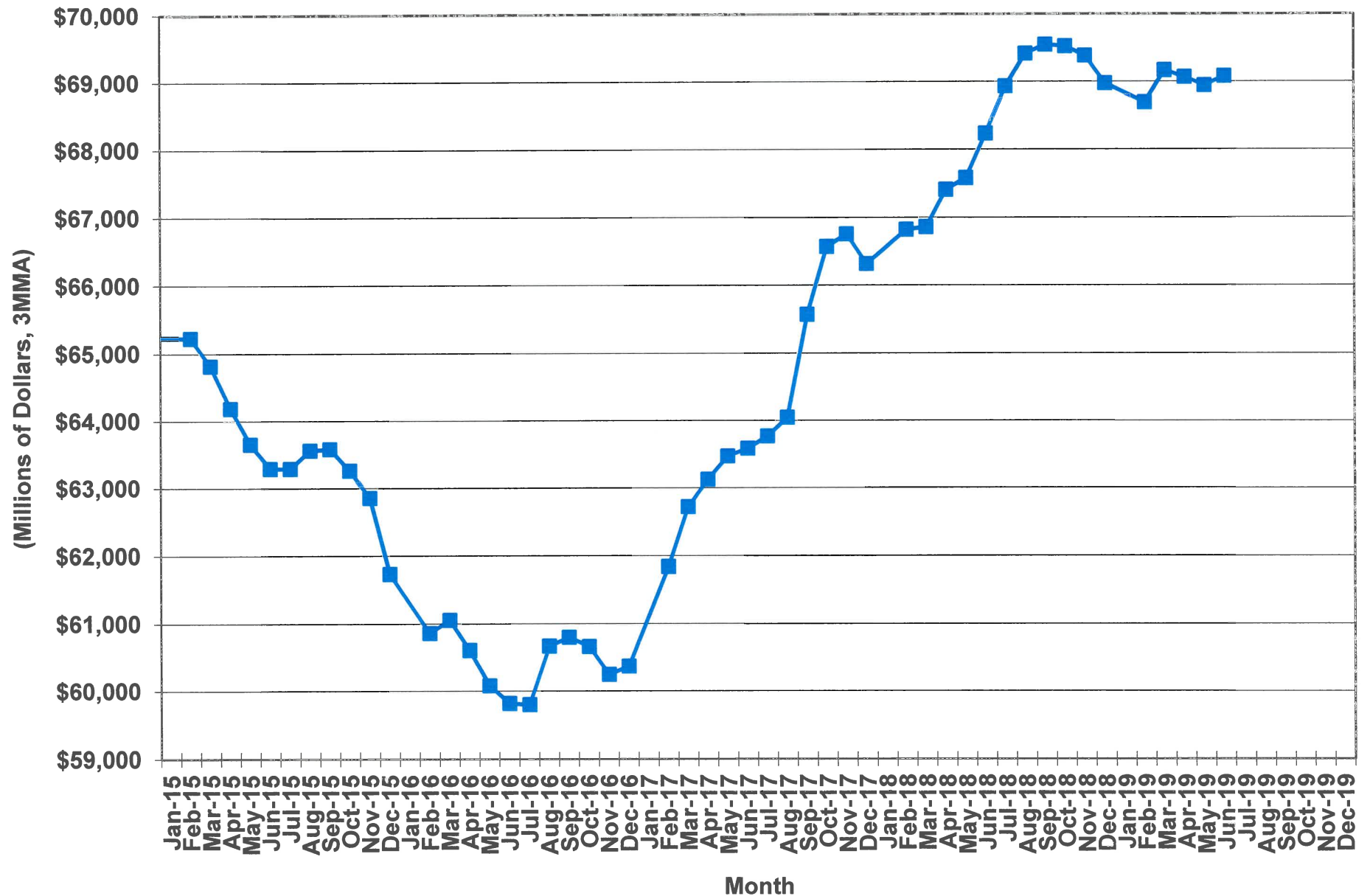
Total New Orders of Nondurable Goods in the U.S.

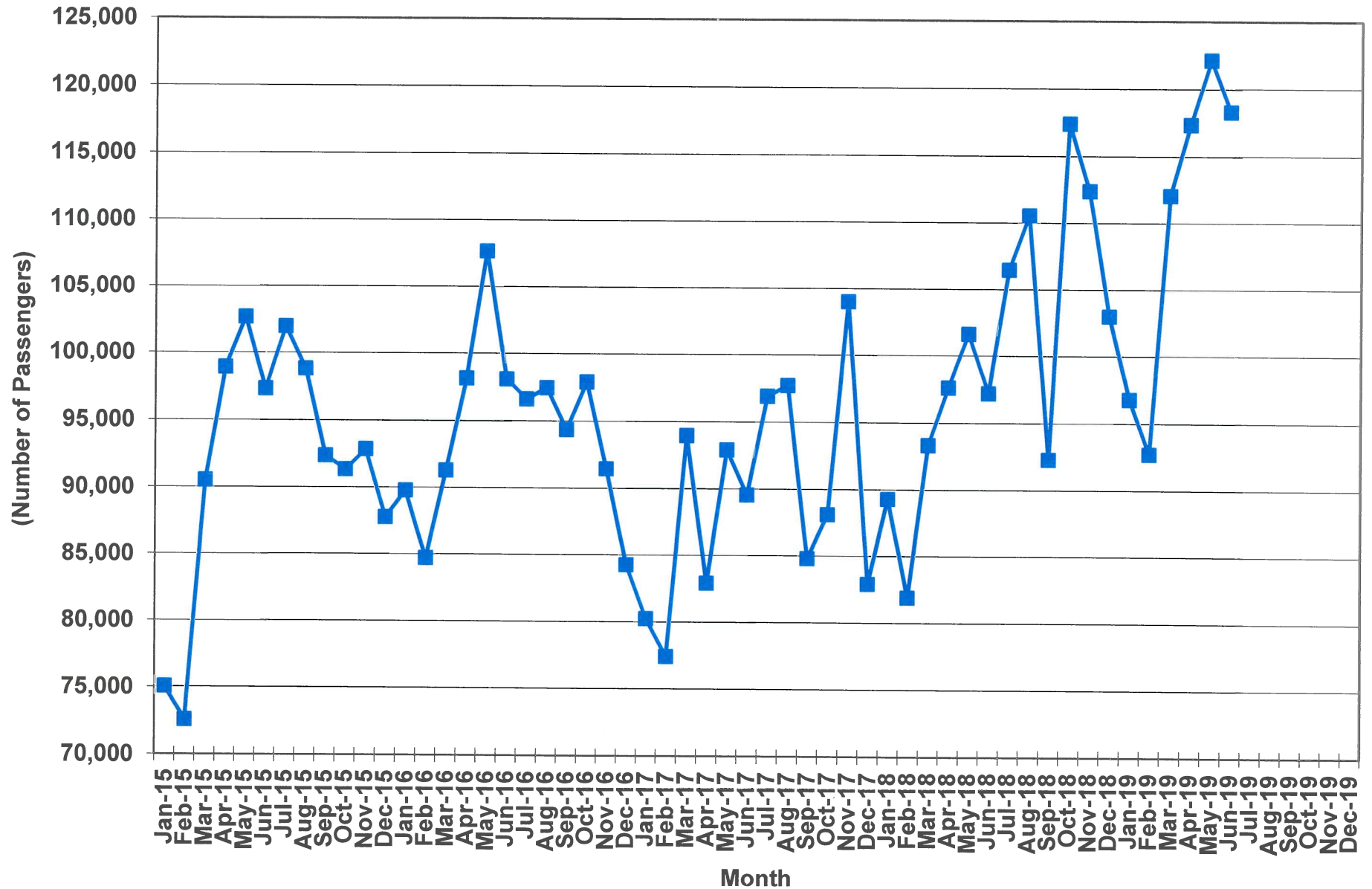
Total Airport Activity Enplanements and Deplanements



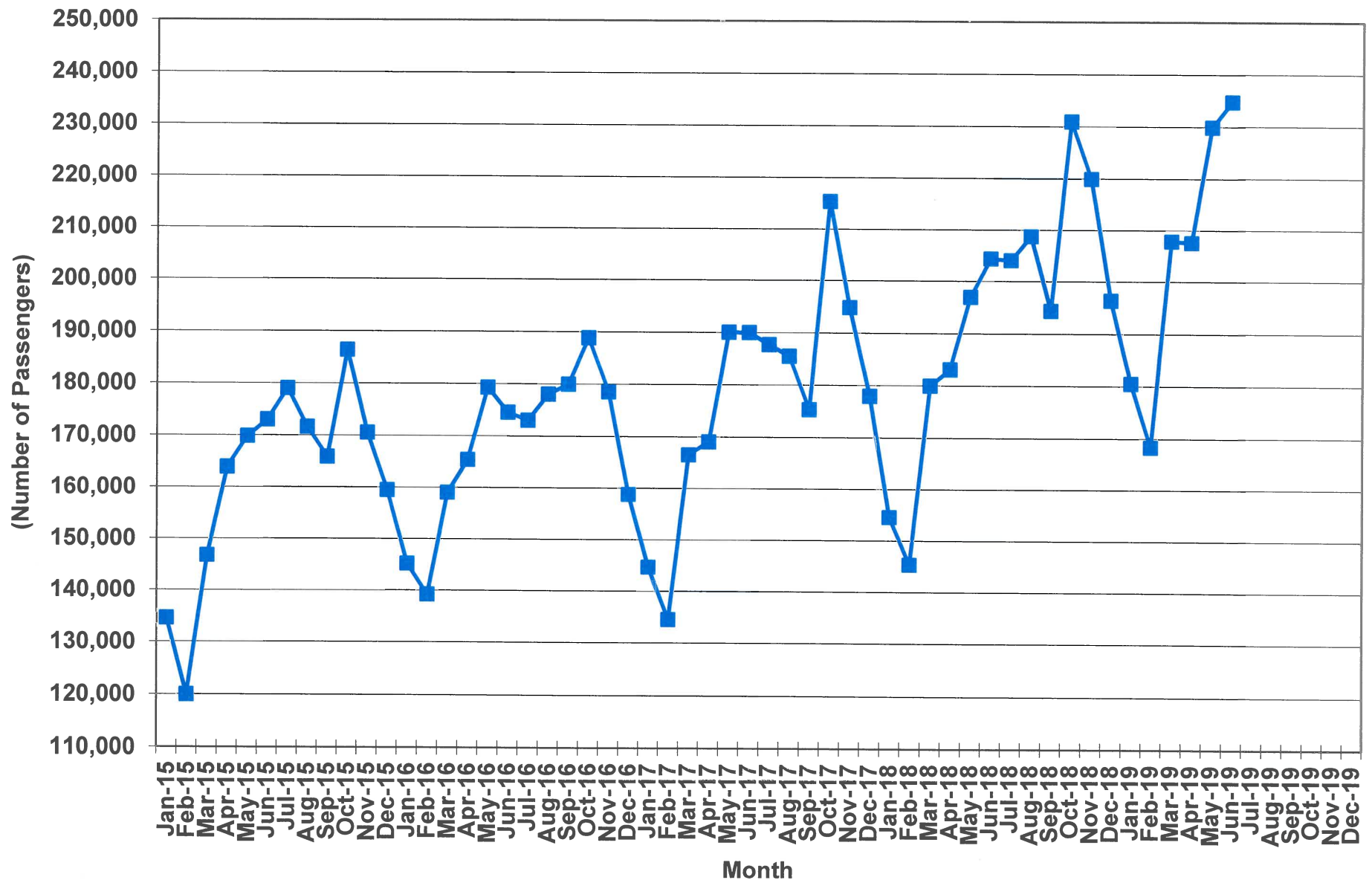

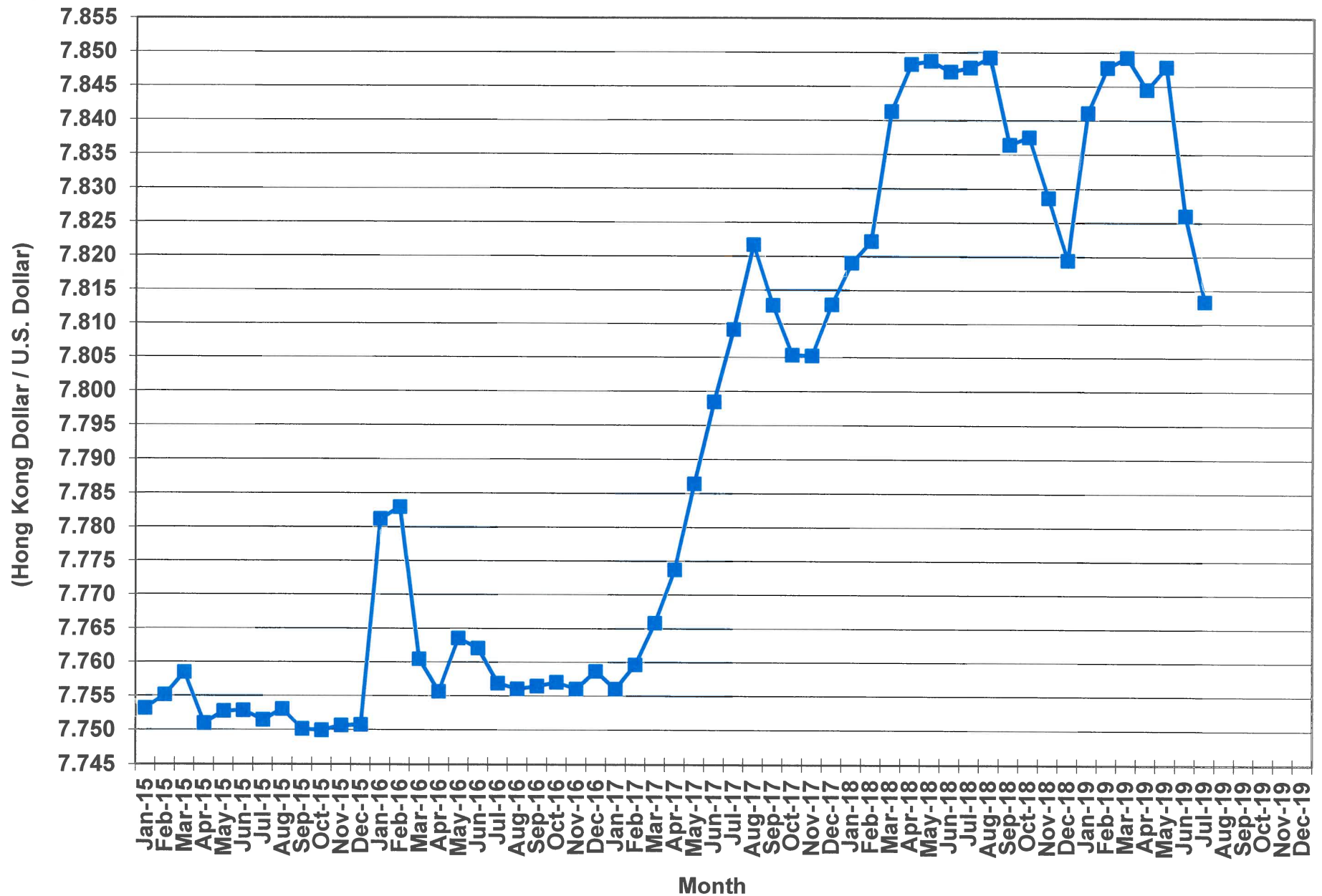
Value of the Japanese Yen vs. the U.S. Dollar



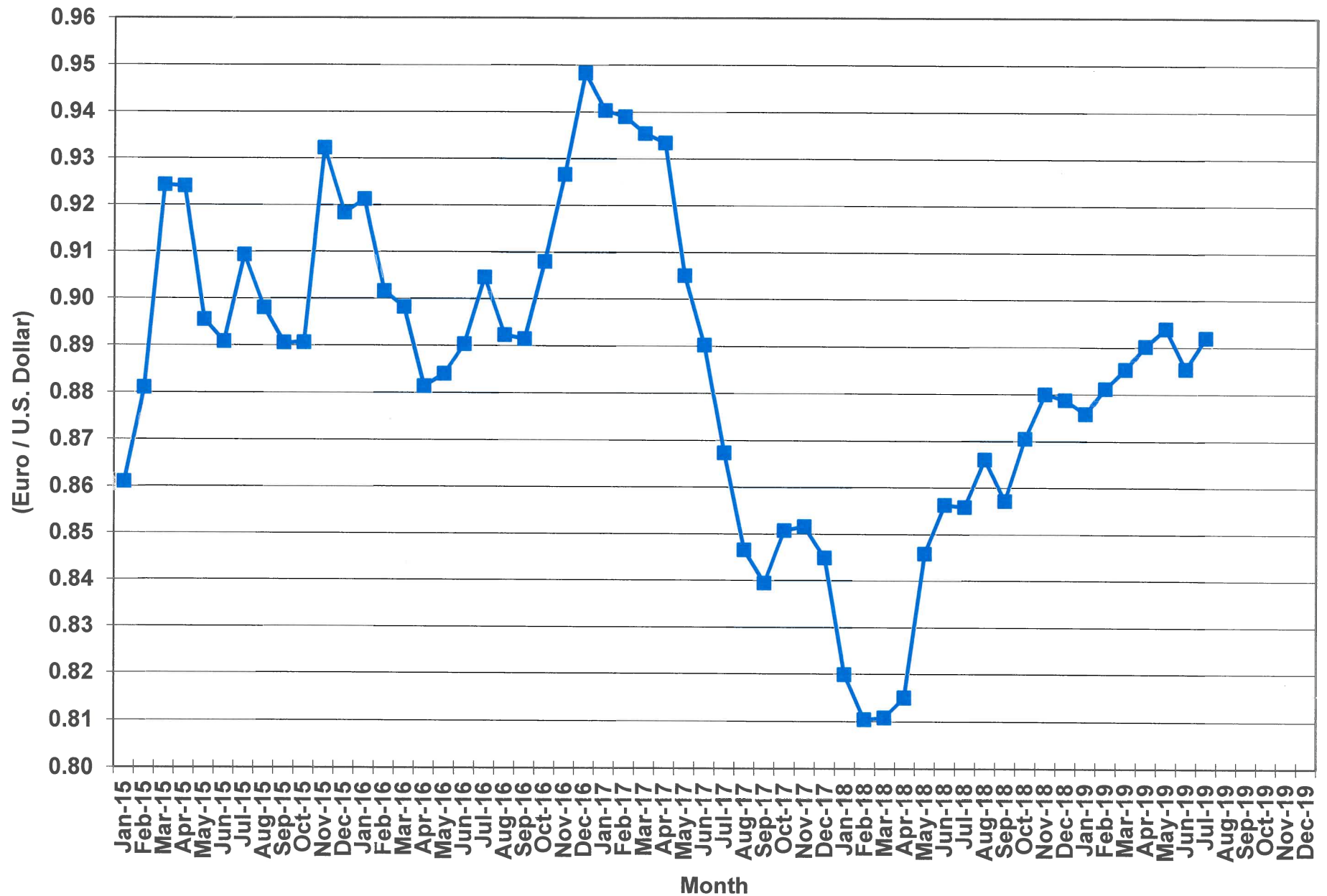

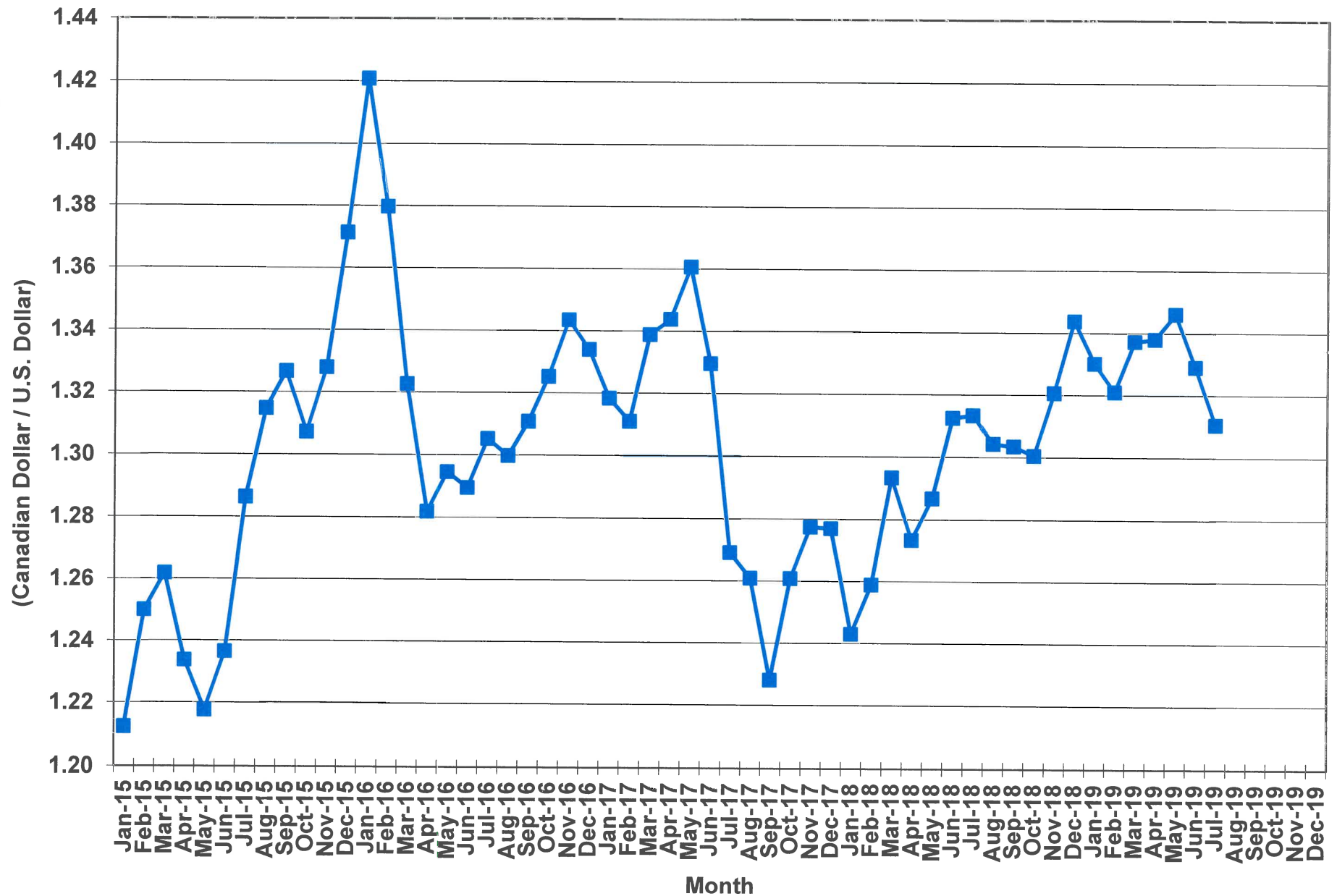
Value of the U.S. Dollar vs. the British Pound



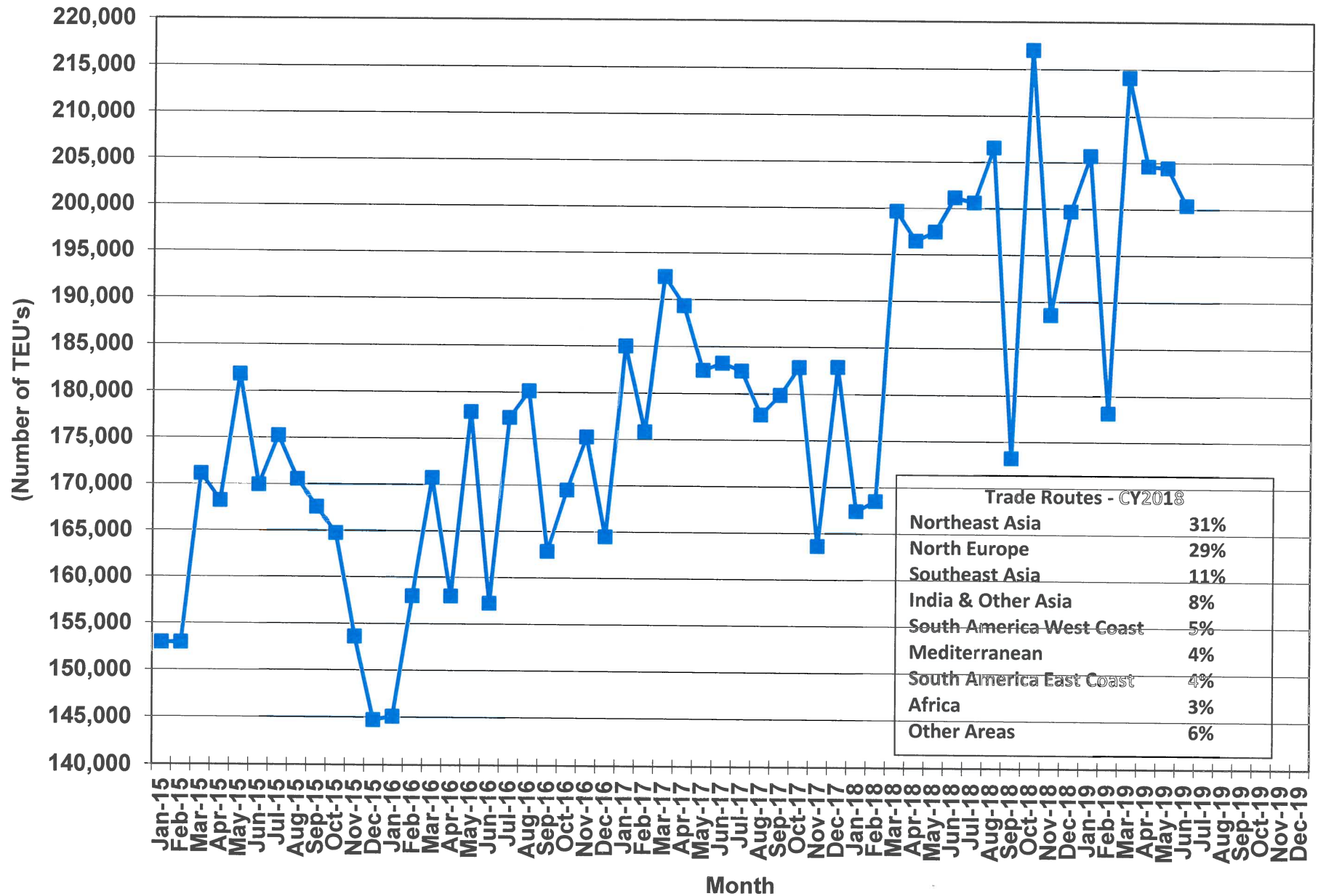

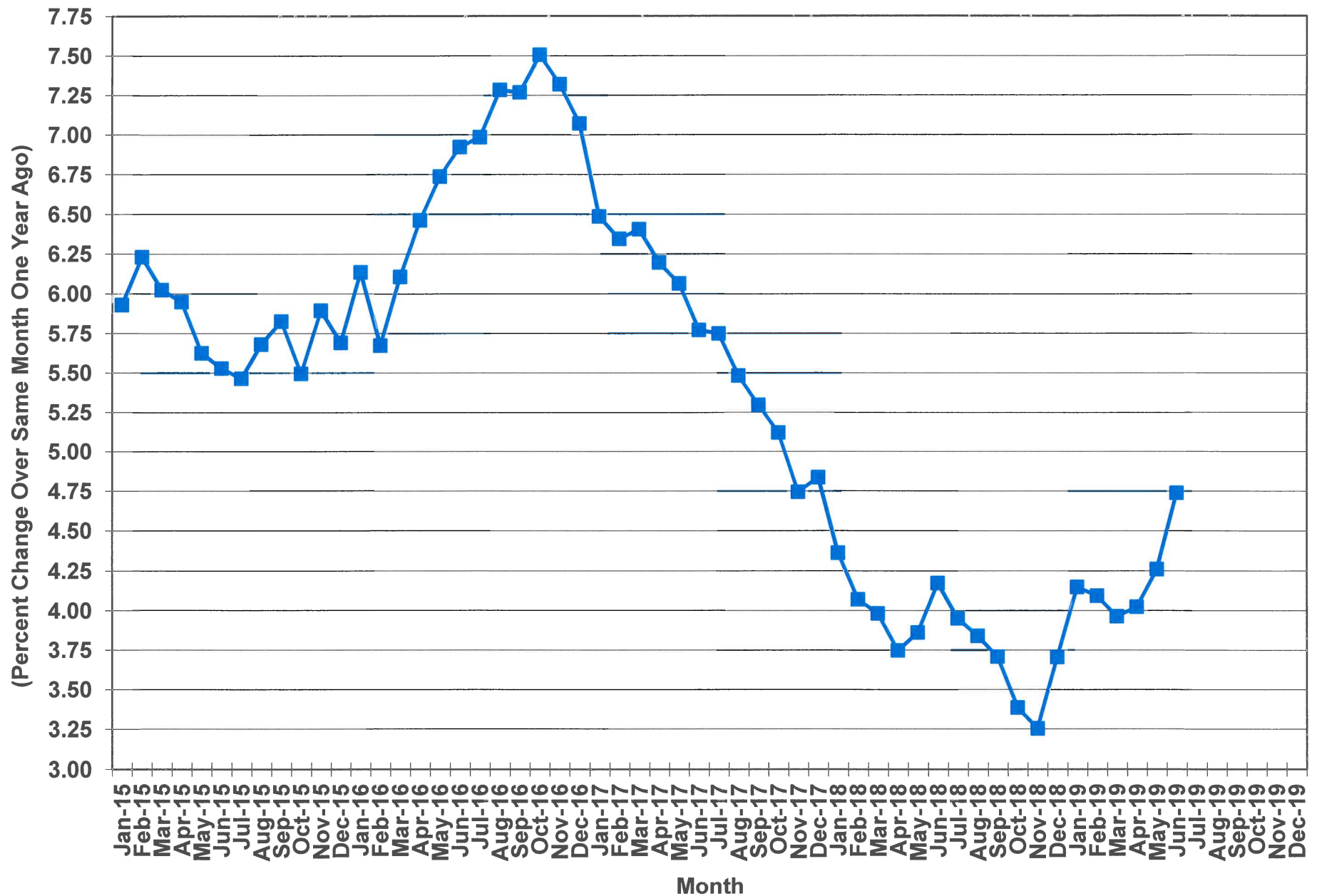
Interest Rate Spread Between 10-Year Bond & 2-Year Bond

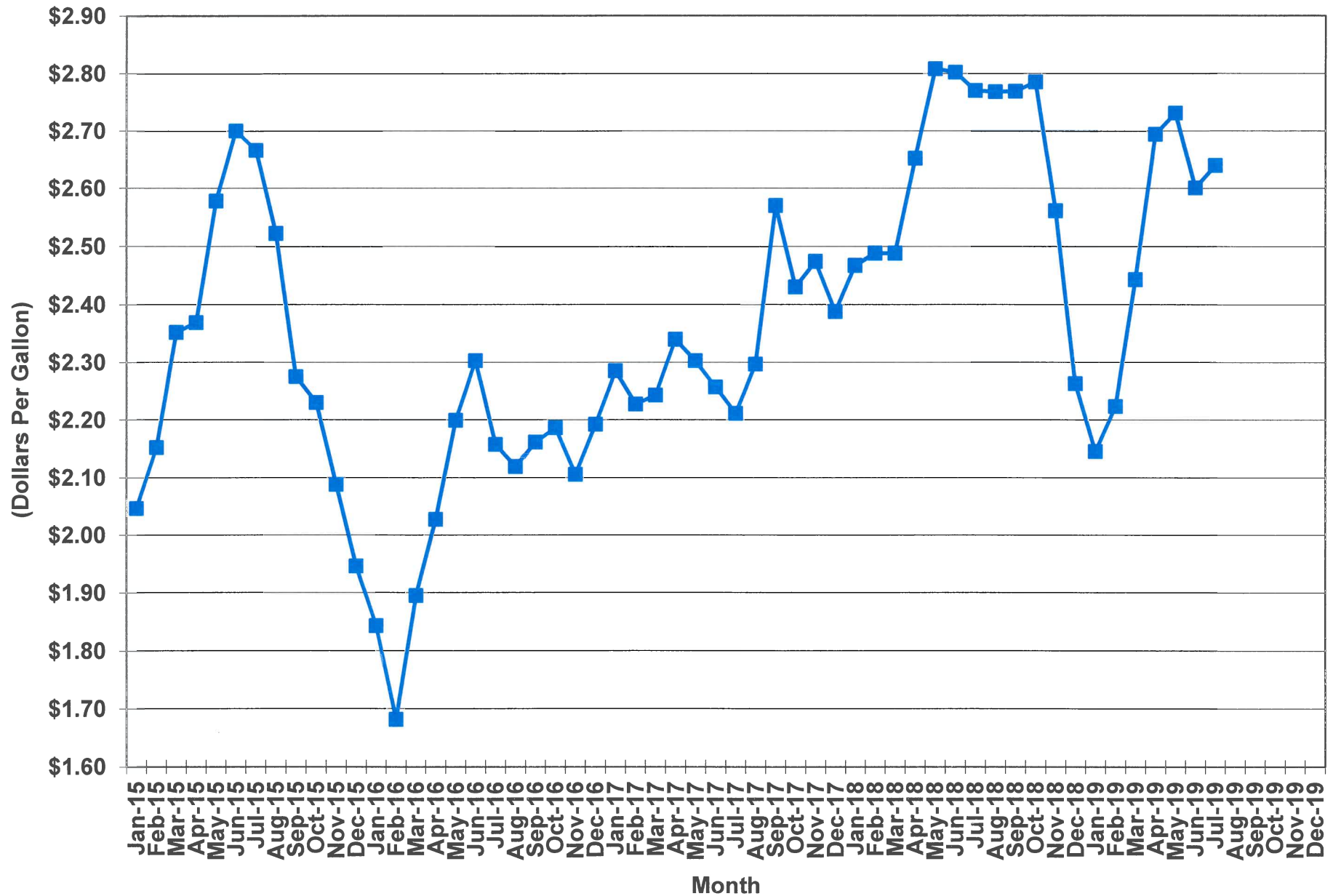
Price of Natural Gas Delivered to Residential Customers in South Carolina



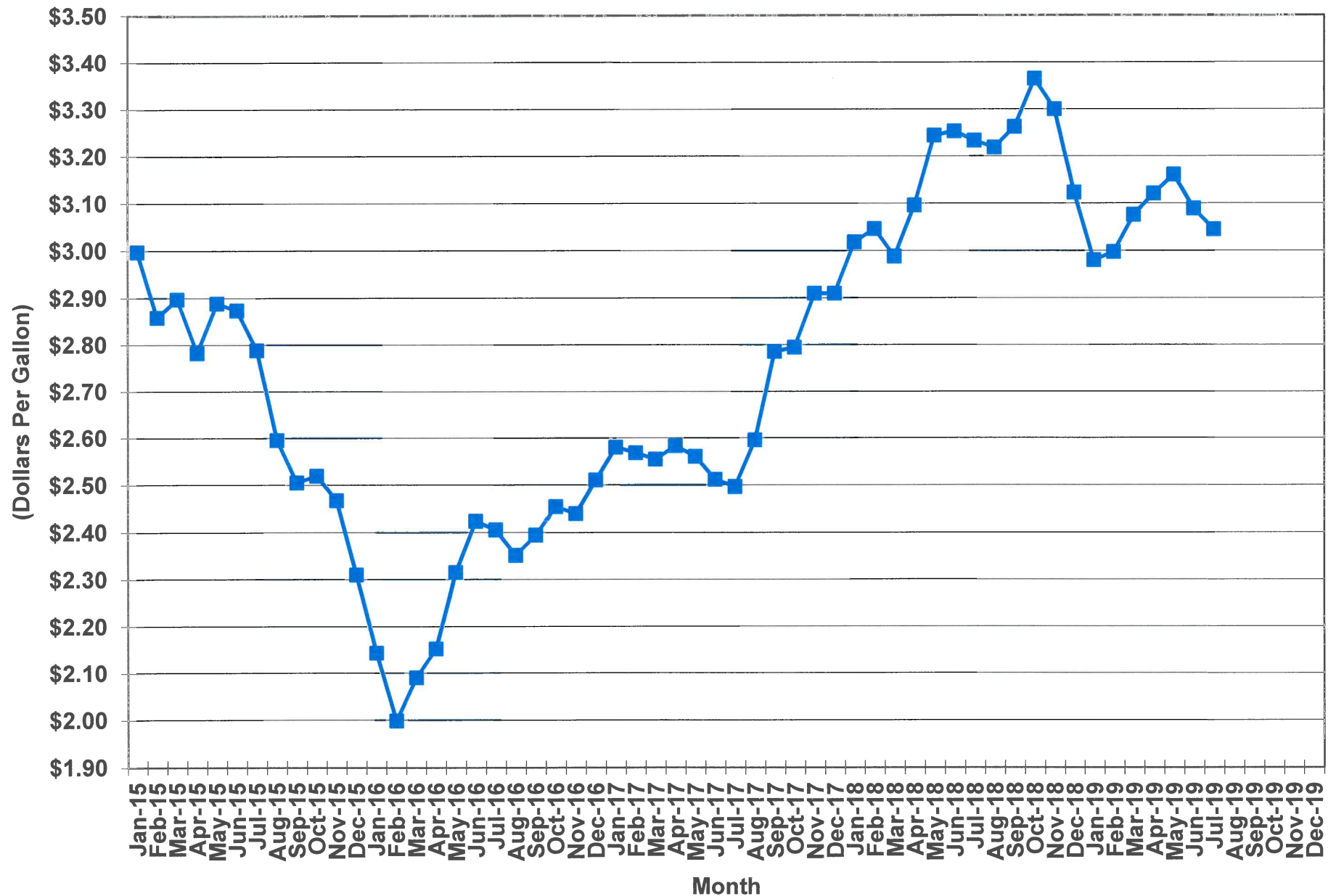

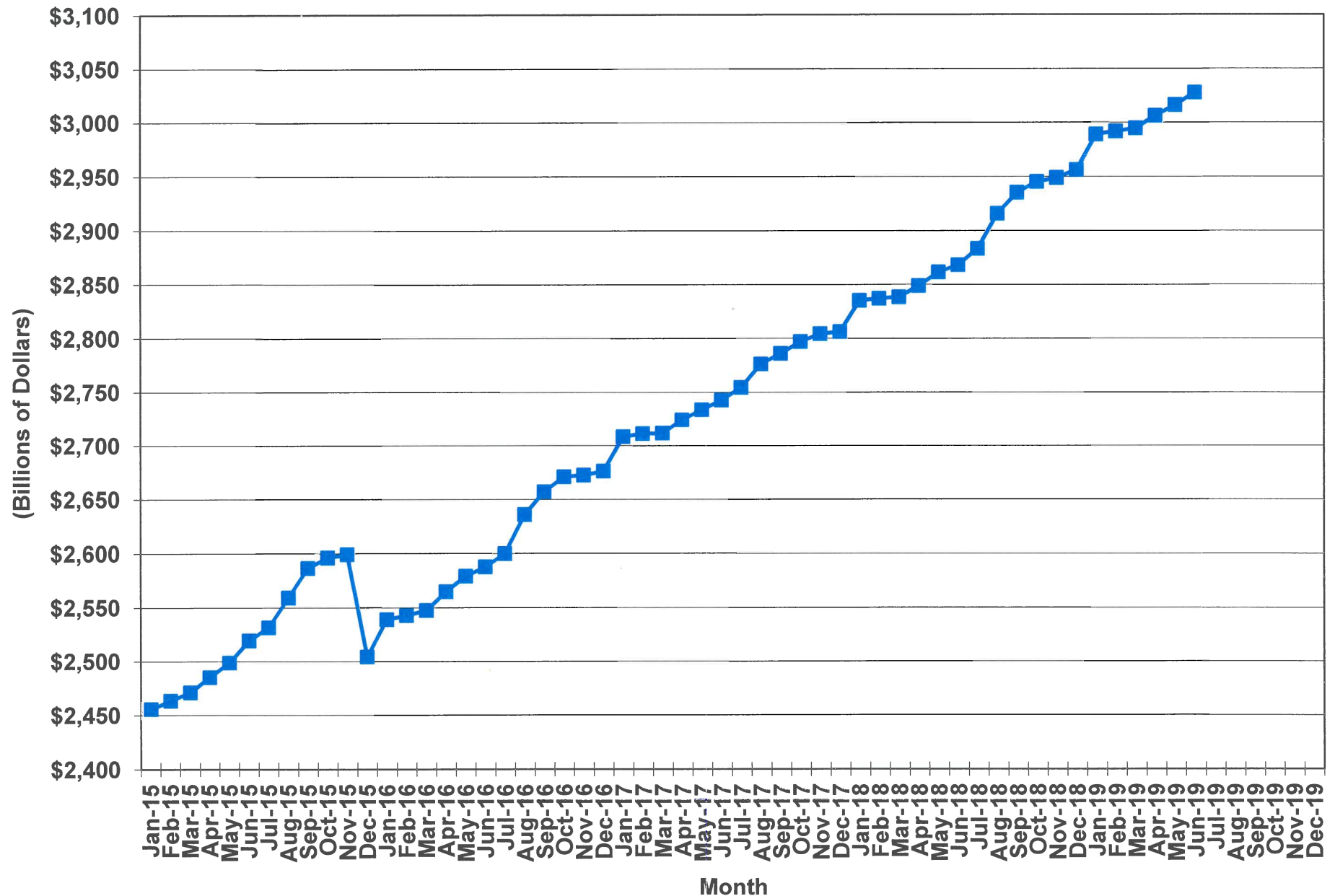
Total Revolving Credit Outstanding in the United States



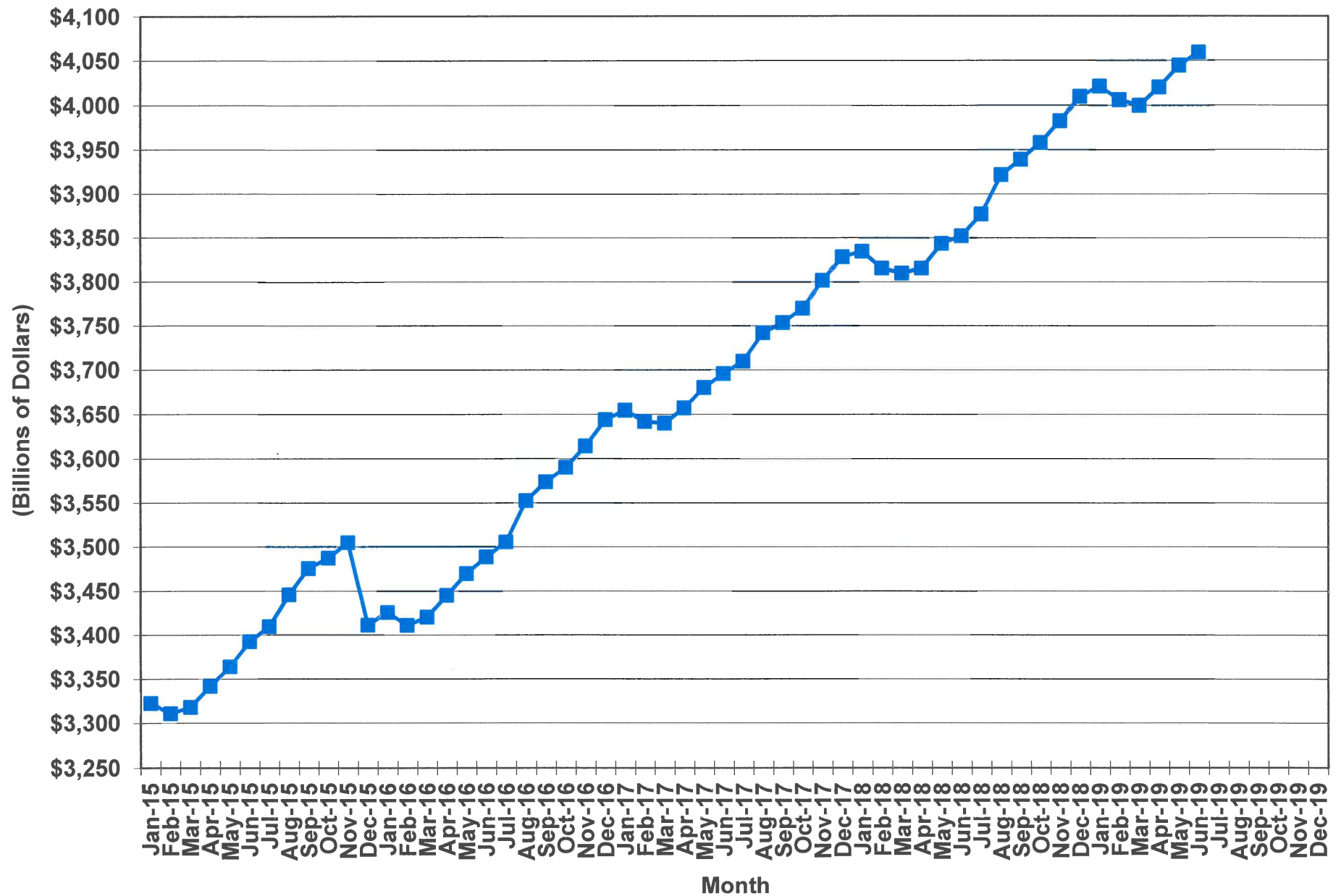
Delinquency Rates on Credit Cards in the U.S.



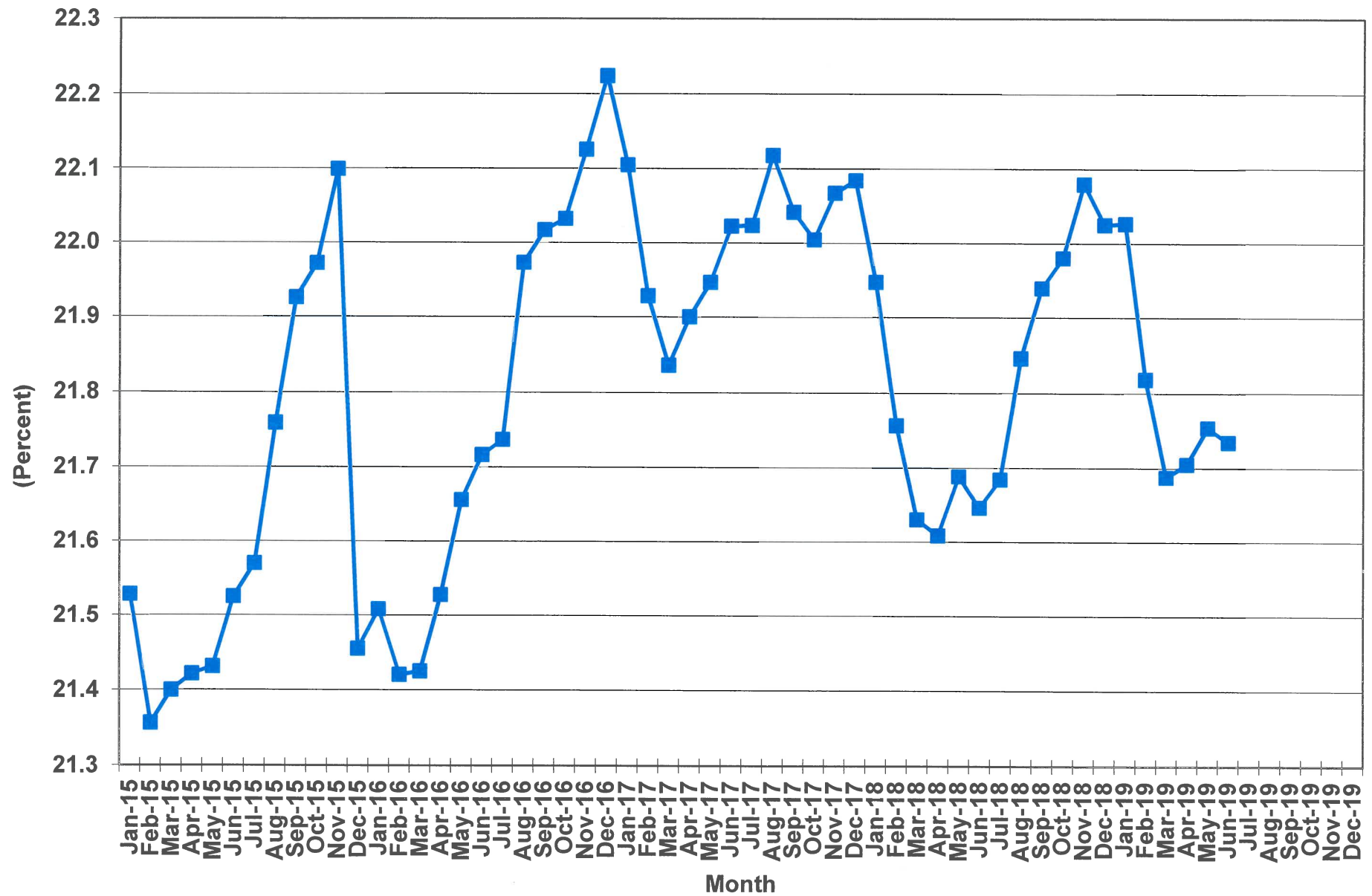

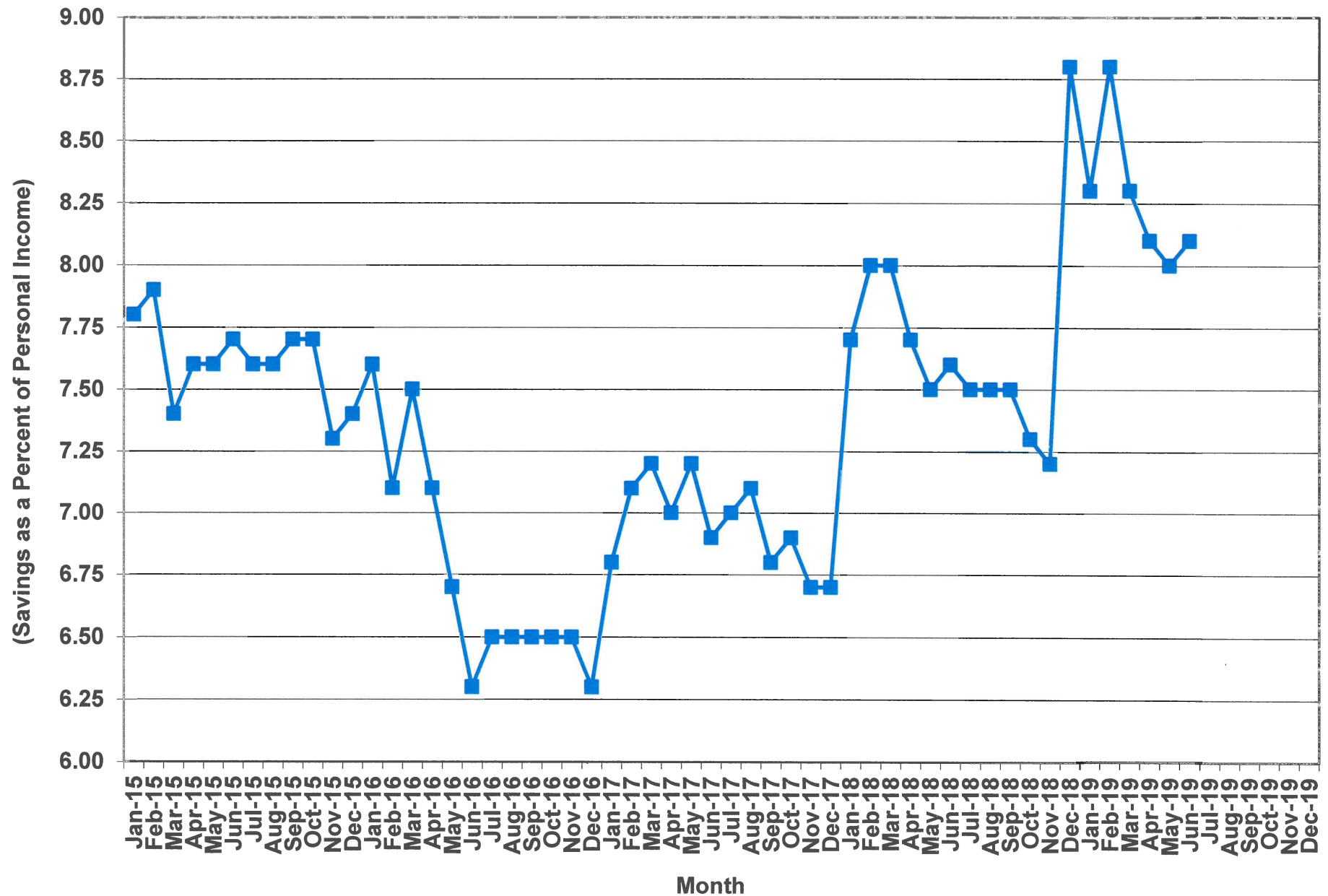

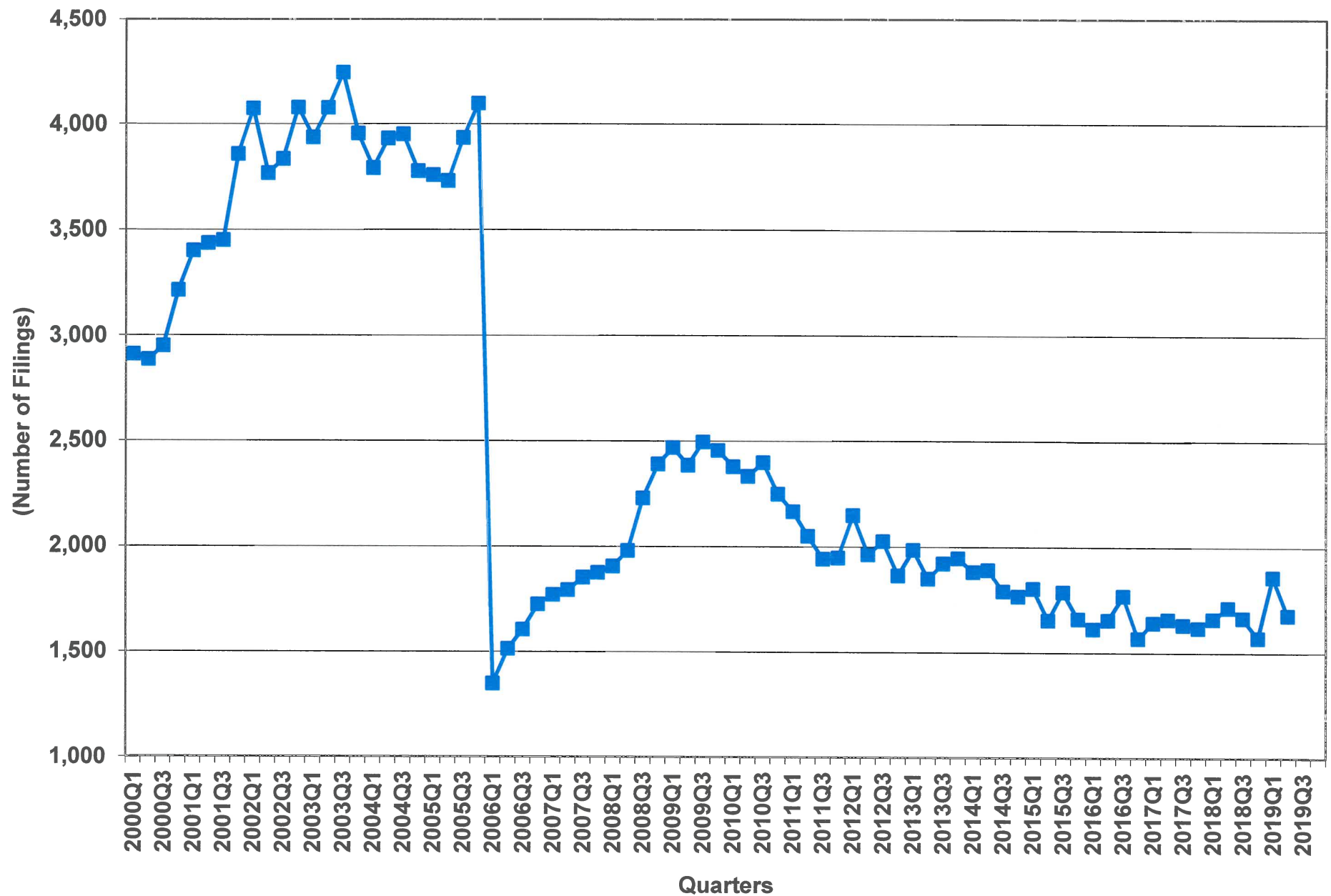
Total Credit Outstanding as a Percent of Personal Income

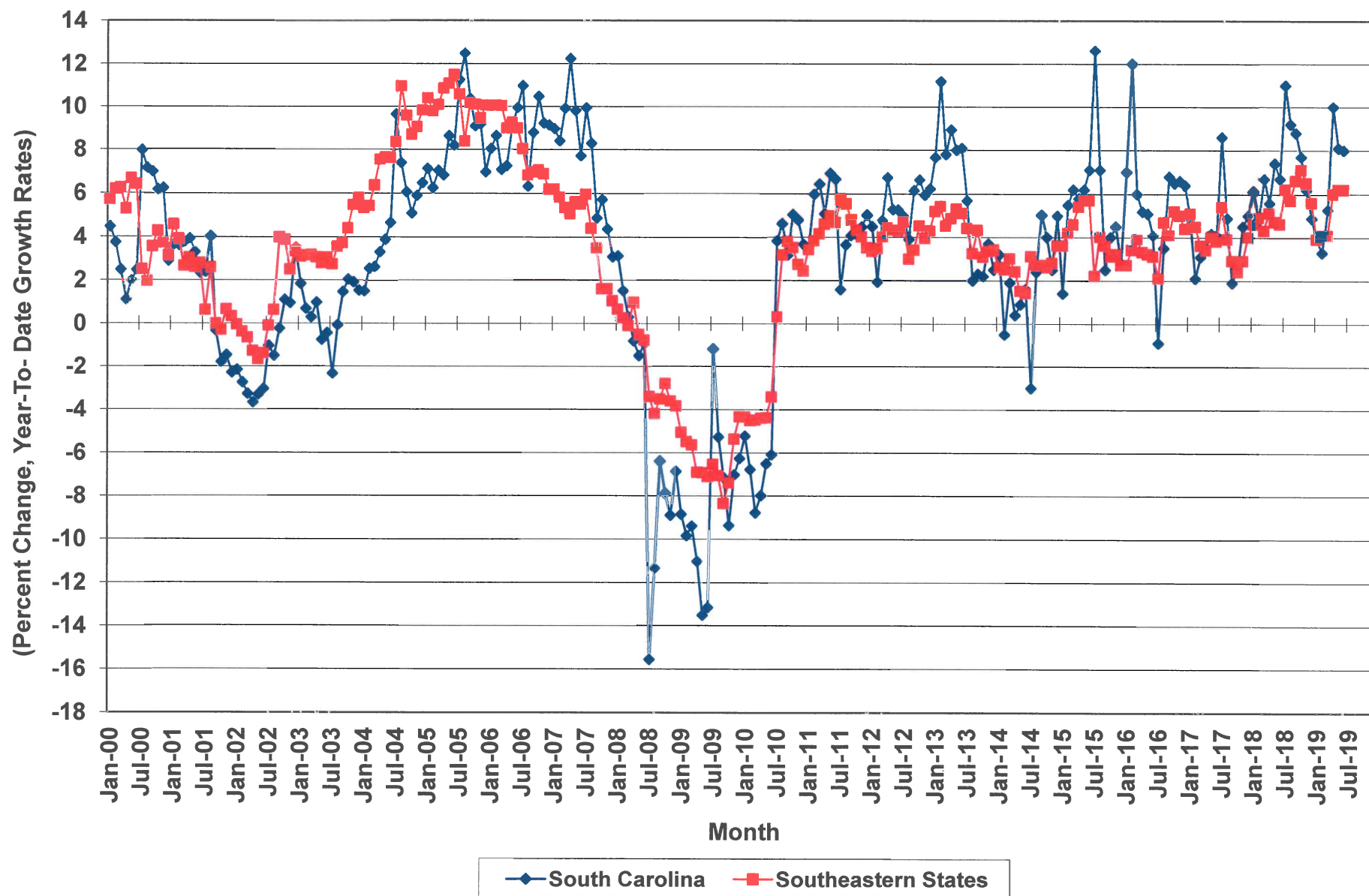

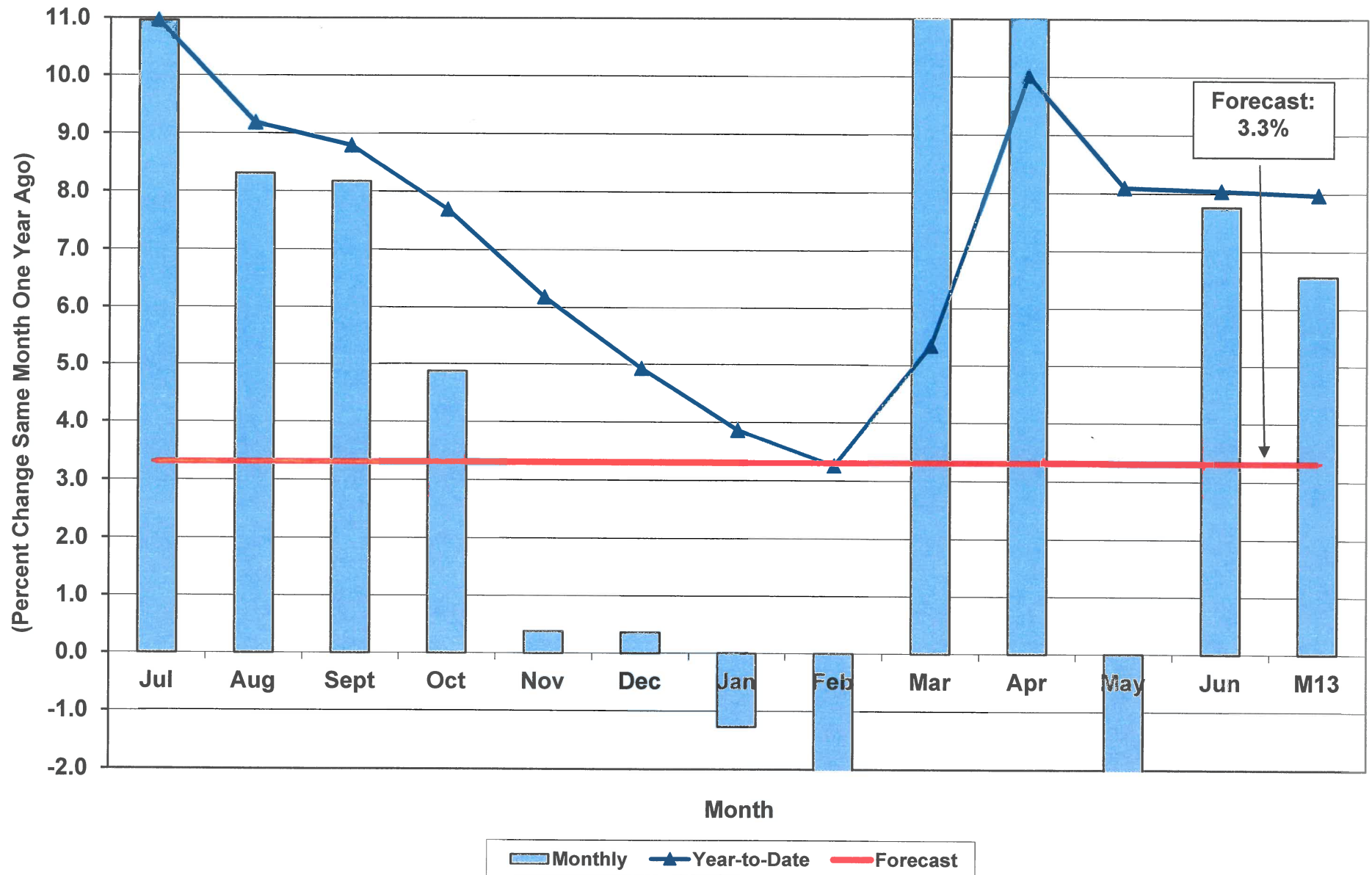

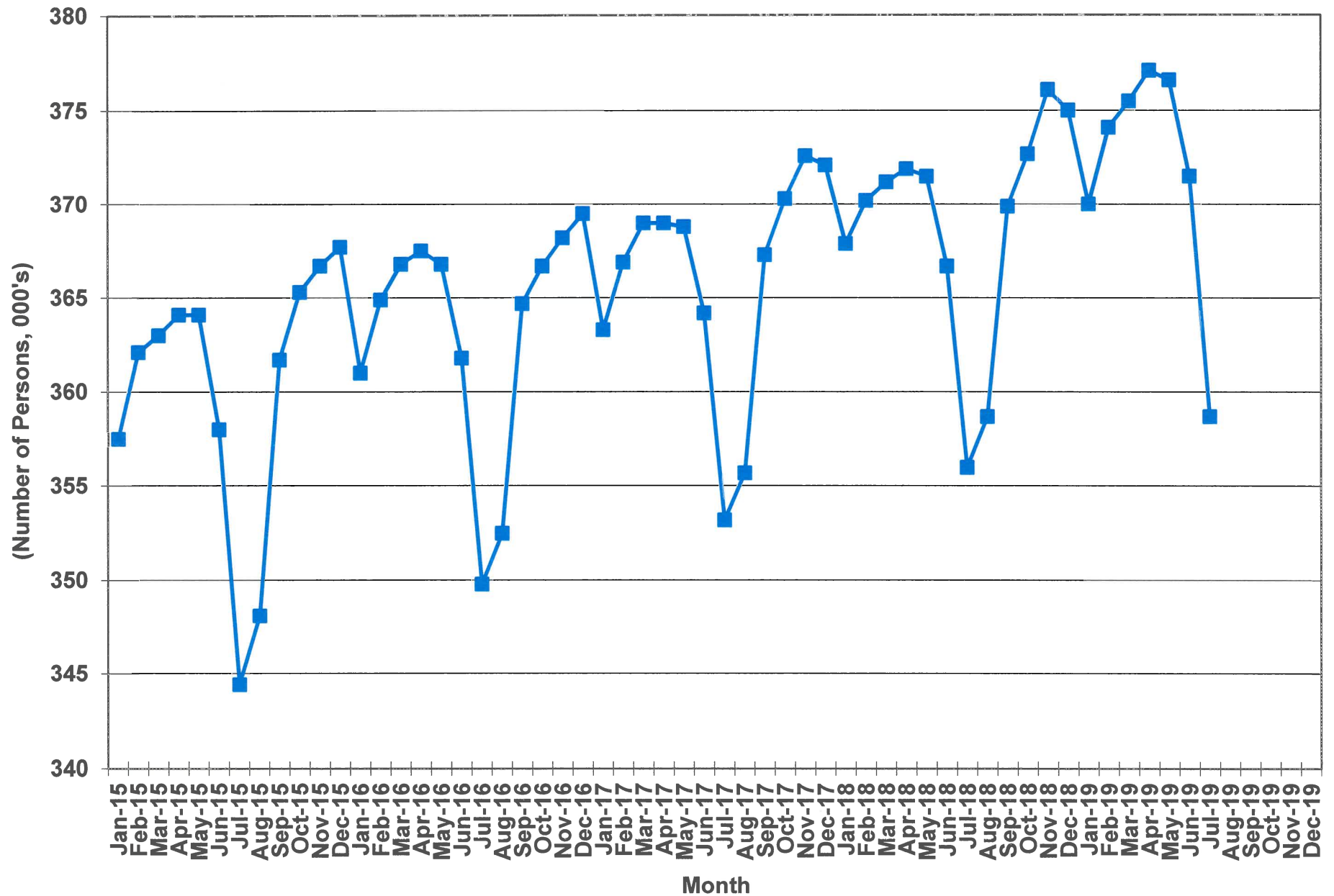
Growth in General Fund Revenue South Carolina & the Southeastern States



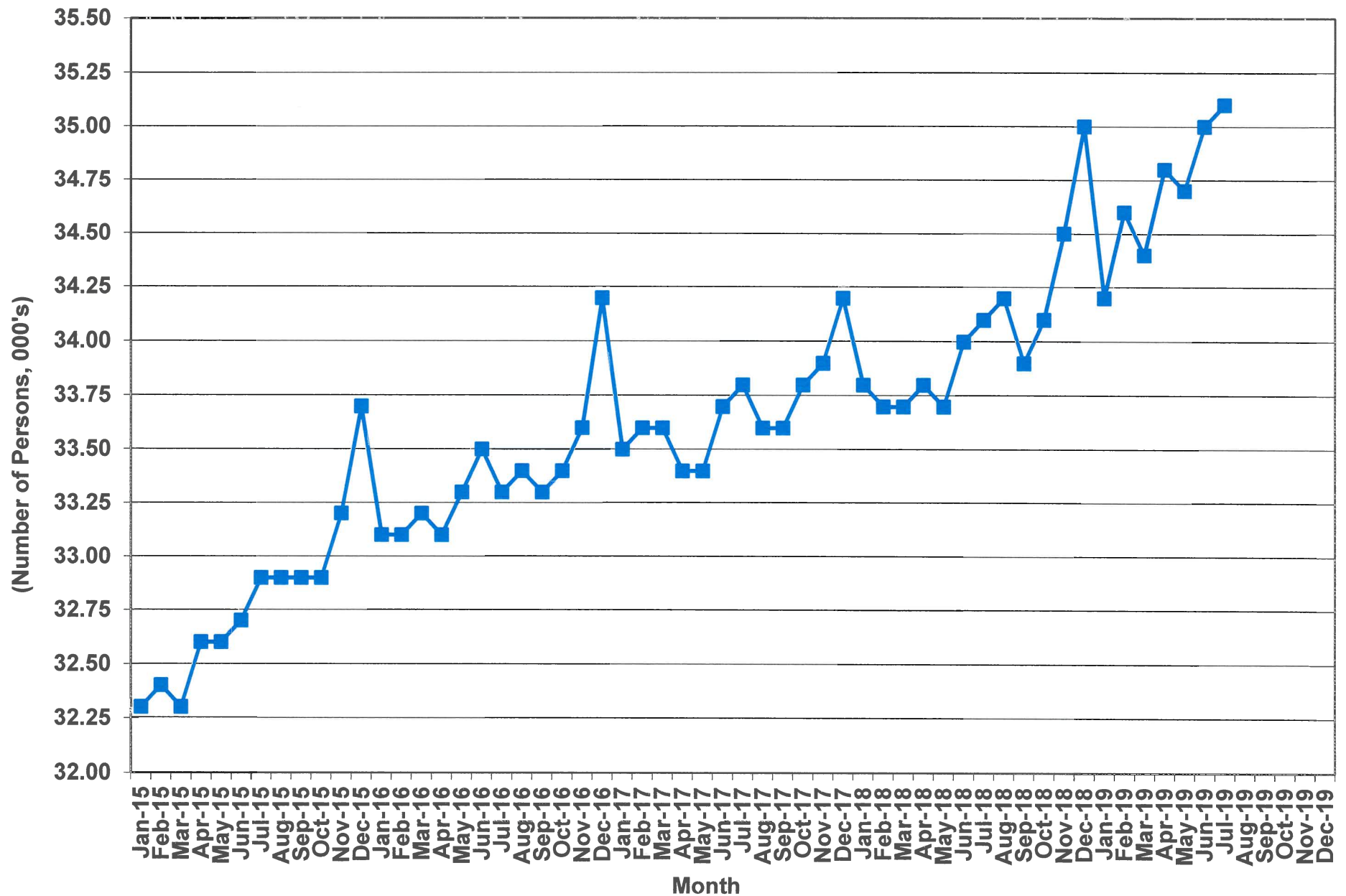
Growth in Total General Fund Revenue Collections FY2019 Monthly and Year-to-Date



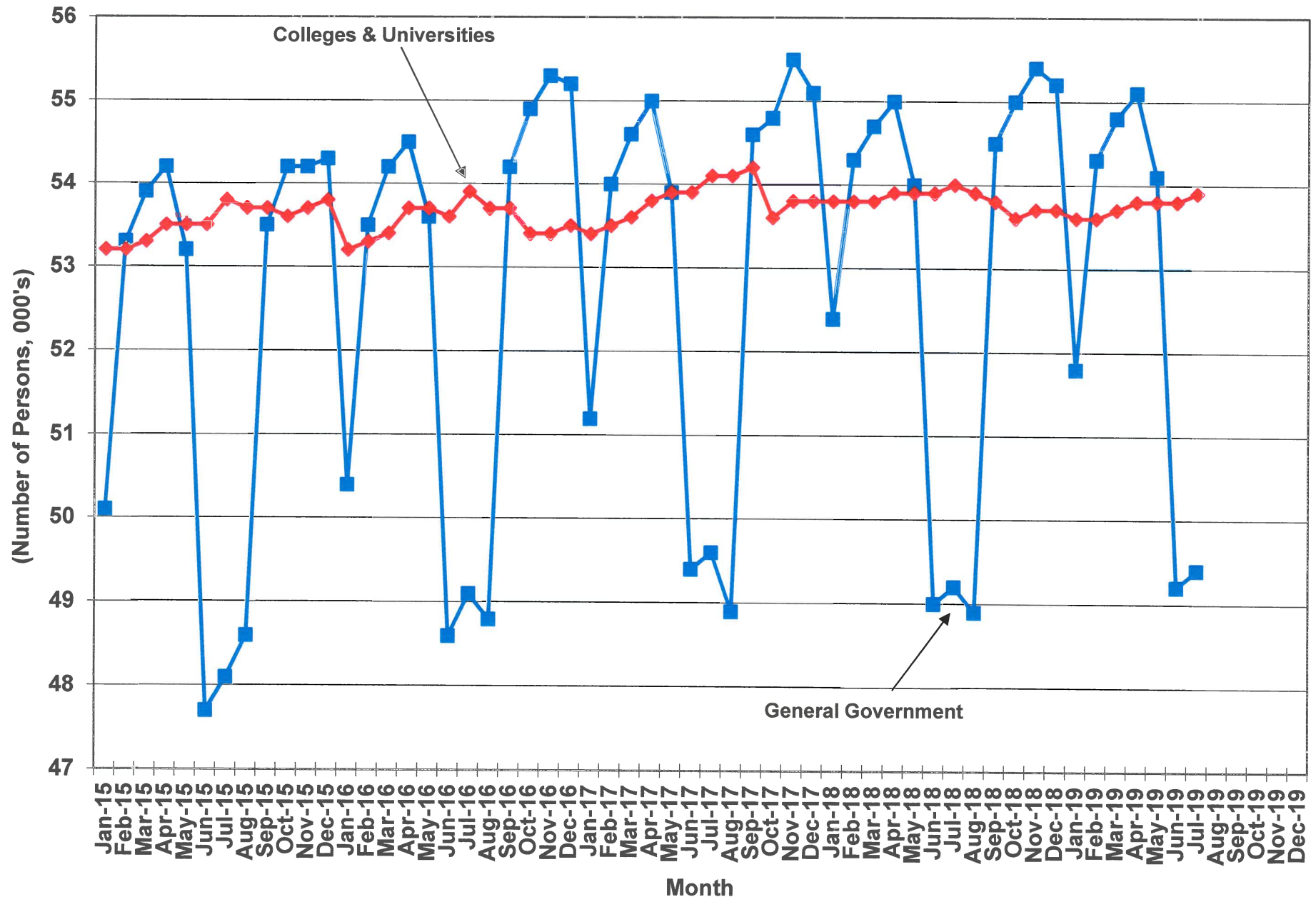
