# **Explanation of Fiscal Impact**

#### Explanation of Amendment by the Senate on May 17, 2016

The amended bill directs the South Carolina Department of Education (SDE) and the Center for Education Recruitment, Retention, and Advancement (CERRA), in collaboration with the Commission on Higher Education (CHE), to survey students enrolled in the state's colleges of education, who have been fully admitted into their institution's teacher education program, regarding their consideration of and the incentives that would cause them to move to and teach in a rural and economically challenged district. The survey results are due to the General Assembly by December 1, 2016. Additionally, the amended bill directs SDE, CERRA, and CHE to explore an effective and practical means to obtain similar information from students in other programs at the state's higher education institutions, with recommendations due to the General Assembly by February 1, 2017.

The State Department of Education and the Commission on Higher Education anticipate minimal expenditures relating to staff time in coordinating the survey of students in colleges of education and in exploring means by which to obtain similar information from other college students. SDE's and CHE's staff expenditures can be managed within existing appropriations and the survey can be conducted without any allotment or further allocation of state funds to CERRA.

## **State Expenditure**
