**Explanation of Fiscal Impact**

**State Expenditure**

Senate Bill 403 amends Section 30-2-310 relating to the collection and disposition of records containing social security numbers by public agencies. The bill prohibits against intentionally making social security numbers or other personal identification information available to the general public. Finally, the bill revises the definition of “personal identifying information” for purposes of this prohibition.

All of the following agencies have reported that this bill would have no expenditure impact on the General Fund, Federal Funds, or Other Funds.
